14) Treating We The People as idiots is never going to be a winning strategy, abusing inalienable rights, freedoms and trusts will not generate peaceful outcomes.

15) On August 24<sup>th</sup> 2021, an Affidavit was served on Nicola Spurrier as Chief Public Health Officer of the private corporation known as the South Australian Government, (and received on 6<sup>th</sup> September 2021) followed by an Affidavit of Default served on 21<sup>st</sup> October 2021 (and received on 26<sup>th</sup> November 2021) instructing her to validate her unsubstantiated claims, that there is an emergency and a pandemic and that the measures taken by her have been justified.

7.
