7. Sat in Court and witnessed a previous case on audio visual facilities.
8. Gallery was full. All can testify that Deborah Robinson was in attendance and the Court convened for the matter.
9. **A false claim has been raised that Deborah Irene Robinson did not attend the Court on 3.10.2023 and has thus had an arrest warrant issued.**

10. Deborah took the stand.
11. Deborah introduced the medical support facilitator.
12. Superior Jurisdiction was announced by Deborah in regard to the Jurisdiction of the medical support facilitator.
13. Judge Priestly exited at this point.
14. Footage is required from the Court in regard to this case please.
15. Gallery was called to form a Grand Jury.
16. Vote was opened and closed.
17. Unanimous vote received.
18. Court clerk to **discharge and strike from the record Deborah Robinsons matter.**
19. Court clerk was unable to respond due to unusual due process.
20. Only 2 Corporate Sheriffs present .
  - 20.1. Footage is required of audio visual material that the Sheriffs may have.
  - 20.2. And Lismore Court footage from the day.
  - 20.3. District Court. Courtroom 2. 3.10.2023
21. Witness of Judge Priestly abandoning the Court upon reference of Superior Jurisdiction in the Court.
22. Judge Priestly did adjourn the matter, as he left.
23. However, the Grand Jury, **a Court of Superior Jurisdiction did overrule** that as an outcome of their vote.
24. The Court room was emptied.
25. Jurors of the Grand Jury assembled on outside pathway to discuss the matter.

26. Deborah Robinson had a medical incident on the pathway: pre-seizure symptoms. Deborah is a known epileptic sufferer.
27. Immediate family and medical support facilitator was invited back into the Court to resume the case.
28. Gallery was not permitted back into the Court.
29. Thus Court became a closed Court.
30. **Offer was rejected** as the Grand Jury had determined that the matter was **discharged and strike from the record.**
31. Thus this standing needs to be recorded at the Lismore District Court.
32. This matter is terminated within the Lismore District Court, a Court of the Board of the Guardians, by **Crown: We The People of Superior Jurisdiction.**
33. And so therefore the arrest warrant needs to be withdrawn and terminated.

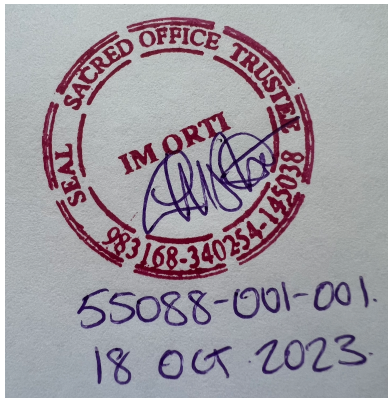
