1.5. Darrell Foote, the applicant, and any other person entitled to, can apply to the Tribunal to vary or revoke the Order at any time.

1.5.1. Darrell Foote has taken the position of Executor and Beneficiary of his Express Trust.

1.5.2. He does not deem himself to be under Guardianship and therefore void of the capacity to make decisions for himself.

1.5.3. He therefore terminates this CTO, without having any need to apply to the Tribunal, as if he was under Guardianship.

1.5.4. IGNORED

1.5.5. Respectfully and responsibly, this IA & I, will await for the responses to the questions posed in this document.

1.5.6. IGNORED

1.5.7. However, in the interim an Estoppel is applied to this CTO until the grounds for its use can be firmly established by this Independent Audit.
