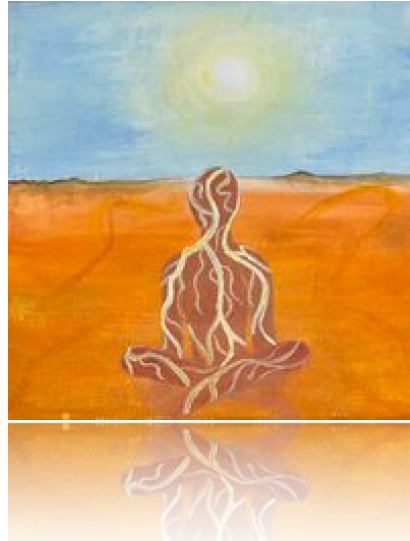

- 13.5. It began with 1302 Unum Sanctum. Some 721 years ago.

- 13.17.3. Indeed this is the Changing of the Ages. So do not underestimate the great changes you are witnessing as Lore/Law is realigned into position.
- 13.18. This case, referred to as the Hume/Rodd case, has been the continuation of that annihilation.
- 13.19. Magistrate Horrigan, is today positioned to either move in favour of legal; and perpetuate slavery: **The Stolen Generations**. In which the repercussions are as per slavery. 25 years jail.

13.21. All of which have been highly documented and repeatedly delivered into this system to alert it of the repercussions of its behaviour.

13.22. First Nations have never ceded Sovereignty, and have never agreed to be under the jurisdiction of the corporate construct called Colonialism.

13.23. Most importantly: without knowing Lawful Due Process, it is impossible to identify the criminal behaviour at hand here.

13.24. Lawful Due Process:

13.24.1. The claimant must prove their claim

13.24.2. The defendant must be heard

13.24.3. Before a competent Court of jurors

13.24.4. Only then can a determination be made of penalty or injury; and actioned.

13.25. Stealing children straight out of community and having a determination delivered **375 days later**, as to whether that should have happened or not, is classified as slavery.

13.26. The Department Child Protection/Trafficking uses a 424 04/21 document to remove children from loving families.

13.27. This is a completely Lawless Document.

13.28. And before a Common Law Court July 30, 2023, a Court of Superior Jurisdiction: this matter was rendered by a Unanimous Vote to be **Crimes Against Humanity**.

13.29. 11 defendants were found guilty of 5 **Crimes Against Humanity** before a full jury.

13.30. All 11 defendants were invited.

13.31. None of them turned up to defend themselves.

13.32. All were found guilty on 5 **Crimes Against Humanity**.

13.37.The Perth Children's Court was officially closed by Superior Jurisdiction 20.8.2023.

14. **Crown: We The People of Superior Jurisdiction** are aware, via the dispatch of the email above named; that the use of **false and misleading information**, dispersed to Public Servants, with a view to presenting a version of reality that is wholly false; has been used to create an unfair influence upon the Public Servant sector.

15. The email is titled **Sovereign Citizens**.

15.1. Thus we will explain, as everyone is a Sovereign Citizen.

15.2. Sovereign is simply the living, breathing individual.

15.3. Do unto others as you expect them to do unto you.

15.4. All are equal before the Law.

15.5. Do no harm.

15.6. And Citizen is the commercial construct of business, and includes tools that help individuals move around the planet.

15.6.1. These include, for example, a passport, a drivers license, a birth certificate.

15.11. The Public Servant sector is not an Authority. It is a Public Servant.

15.12. And when it is witnessed to be breaking Lore/Law via its private legal system, the Lore/Law will step in to assist in correcting that.

15.13. That is what the Common Law Sheriffs do. Attend matters and hold accountability to **failures of Lawful Due Process** that may be causing **Harm and Injury**.

15.14. In the vast communications **Crown: We The People of Superior Jurisdiction** have submitted throughout 2023, with regard to the missing Hume/Rodd children, the Australian Government, a private corporation positioned as a Public Servant; has at all times, deemed itself not answerable.

17.1.5. before Lawful Due Process:

18.4. To be positioned to be job seekers, when they are young parents

18.5. Is 100% slavery.

18.6. Including loss of income for Grandmother, Vicky Penny, with the taking of O'Shea, also by failure of Lawful Due Process.

18.7. All children show extreme standards of distress.

19. For clarity: any alleged claim of 'they accept benefits, therefore they are under the jurisdiction of the Australian Government' is wholly false.

19.1. That would be dependent on the Australian Government having a separate and independent source of revenue that it was using to support Centrelink payments.
