Trust of the Future Fund and will be accountable to Community Auditors, with a centralised, transparent, public gazette, facilitating full transparency.

34. The Board of the Trustees, will make all matters transparent, and will be beholden to the instructions issued to it by the **Community Audit teams of We, The People, of sound, and competent mind**'.
