20. 27. We began this journey of change of jurisdiction at the Spring Equinox 23.9.2021, on the slave axis, and, 6 months later, again we are here at the slave/service axis.
28. Let us blueprint here today, and again place into the ethers, that we as a humanity are done with slavery.
29. We do not have one jurisdiction to rule over all others
30. And always emerge triumphant

32. To allow this to continue is to allow a continuation of **Injury to Law**.
33. With injury to Law, we have death, and destruction of culture and resource use.
34. This is all we have known for thousands of years.

35. Thus, the Grand Jury request the Jurors to vote on the following:
 - (i) **ORDER #1**: Is it nature that produce the multi-cultural diversity of the human experience, and therefore a diversity of jurisdictions manifested through language and custom?

 - (ii) **ORDER #2** Is it a **fraud** for one jurisdiction, created not by nature, but by an instrument of legal fiction, namely a Papal Bull, to allege to have superior jurisdiction over all others?
