1. Terra Australis Grand Jury 4 Order #2 21st December 2021

1.1. ORDER #2

1.2. A response to the vaccine agenda. :

1.3. There is no such thing as 'mandatory' access to the body as that defies the primary principles of Law/Lore, specifically the need to acquire **free will and informed consent** for such a procedure, at all times.

'**Terra Nullius**' was an attempt to give 'legitimacy' for the British and Australian governments to allow the dispossession of all Indigenous Peoples of their land.

7.4. Mabo 2 in 1992 led to the Australian Parliament passing the Native Title Act in 1993. An Act which places the land under the management and decision making mechanisms of Parliament. It has resulted in long and arduous cases whereby tribes allegedly needed to prove their provenance to the land, to this **invading** force.

It is completely farcical. Another word for farcical being ludicrous. Also known as an '**absurdity in law**'.

7.5. The Native Title Act 1993 (NTA) gives recognition that "Aboriginal and Torres Strait Islander people have rights to land, water and sea, including exclusive possession in some cases, but **does not provide ownership**".

7.6. Under Native Title, commercial rights are generally not recognised. This means that First Nations people are **unable to make money from their Native Title rights**. There are also no rights to minerals, gas, or petroleum that might be found on their lands.
