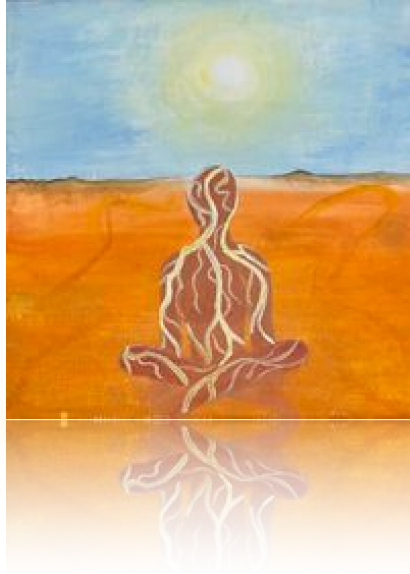

3. The corporate entities under review in this investigation thought they had the capacity to terminate the investigation.

3.1. Those entities are now aware that such presumption **does not exist**.

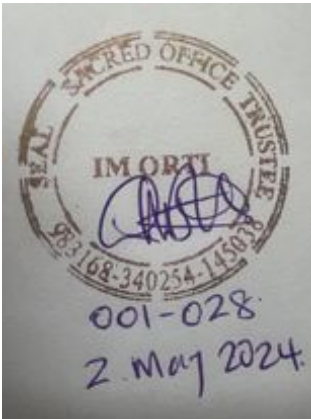
