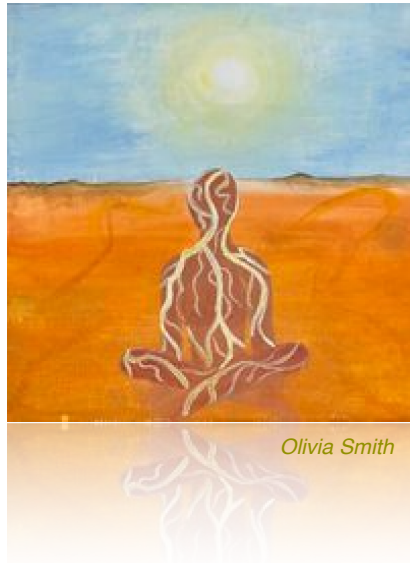

31. And moved against the clarity of the content of our phone conversations.

31.1. Did Alison explain to Shakira she was not in a position to 'represent' her, since it has been made abundantly clear that Sovereign Jurisdiction is at the table?

31.2. Did Alison explain to Shakira that re-presenting Shakira would result in the dissolving of her Sovereign Jurisdiction and she would come under the Statutory and Legislative framework of the Private BAR Guild and be deemed incompetent before that Private BAR Guild Legal framework? Legal but not Lawful framework.

31.3. The Private BAR Guild is a class based system. It is a slave system

49. And this is reflected in immediate Penalty Notices being issued.

50. We will not have our valuable time wasted by Belligerent Occupation.

51. I suggest you take these matters much more seriously.

52. You have **trespassed** upon the Sovereign.

53. Any further **trespass** will be dealt with very swiftly with

53.1. A further Penalty Notice

53.2. A Public Listing for Dismissal

53.3. And frozen assets to be liquidated for damages.

54. This is a zero tolerance landscape.

55. This is Lore of Laws.

56. This is not a legal fiction commercial landscape where Humanity is positioned as the chattel slave and *'anything goes in the Wild West'* as Elder Uncle Otto chooses to describe it.

67. And will swiftly remove the standards and/or the perpetrator.

68. The Private BAR Guild is a privately owned legal system, overseeing the infrastructure of the corporations that are owned and paid for by the Sovereign, on these Lands.

69. That is what the **receipt**, commonly known as the Birth Certificate is.

70. It has been void of Terms and Conditions until now. Due to the lawless instrument known as Guardianship.

71. That structure is finished now.

72. We are in charge.

73. And these are the **Terms and Conditions**.

74. You, and those around you, including new email identified of Northern Territory Attorney General: Ben Wild; are **Public Servants, paid on the Public Purse**.

108. And that these payments had nothing to do with a final settlement, as settlement would be long and ongoing to cope with a potential life long injury.

110. And that hardship would **not** be endured whilst years of legal wrangling unfolded.

111. You agreed.

112. And that we had ZERO interest to wrangle in any way with the private BAR Guild, of inferior Jurisdiction and the **abundant** insurance policies that are owned by the Sovereign.

124.and that 5 people were injured.

125.Not just Shakira.

126.The fact that Shakira has not signed as a blessing to Sovereign Jurisdiction, indicates she is unclear about jurisdictions.

127.And is perhaps thinking it was a choice of myself or Alison.

128.Not realising that Alison is inferior jurisdiction and is engaged by the Sovereign; of Superior Jurisdiction.

129.At no time have I put myself forward to 'represent' Shakira.

130.This is an Audit by the Sovereign.

131.You and I were clear; Alison - a legal practitioner of inferior jurisdiction - was working under the Sovereign wing of Lore of Laws - Superior Jurisdiction: Elder Uncle Otto and myself.

135.**The consequences** of your attempt to dismiss the Sovereign on Friday, in your email, indicate the following:

135.1.You have moved against the Sovereign and have therefore committed:

135.2. treason, fraud and slavery. Criminal code 270 - slavery, 25 years jail.

135.3.You have attempted to **isolate** the family and expose them only to the voice of the legal fiction system of the private Bar Guild that likes to call itself Law, but is not Law.

136.3.1.This is an **Independent Audit and Investigation** by the Sovereign.

136.3.2.Into inadequate systems that create disastrous results.

136.3.3.It began that way and it will continue that way.

136.3.4.It has nothing to do with whether Shakira issues consent or not.

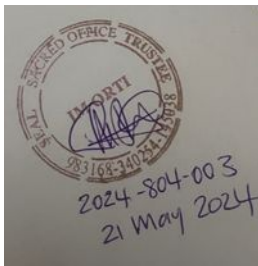
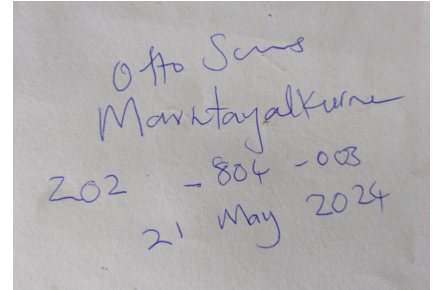
