  - 12.2. Assuming I was just throwing a bit of business her way.
  - 12.3. We are the providers of that pay cheque.
13. By evidence of his email on the communication from Klarin Sivyer, 17.5.2024, Ben Wild has moved to close communications with the Sovereign, Elder Otto Sims and Ormay, and myself.

14. To date: no one has made contact with Elder Otto Sims whose land this entire structure sits upon. Without permission, blessing, treaty or Bill of Sale.
15. I remind you the Australian Government is a private foreign owned corporation.
16. An extension of the East India Trading Company, that decided it would make itself a 'government'. And a part of the Rothschild empire. Now defunct.
17. It is a commercial enterprise, existing via the monetisation of the birth certificate.
18. It is not the Landlord.
19. It has zero paperwork to support such a claim.
20. In fact, it is a Belligerent Occupier. A war criminal. Leaving injured parties behind its quest for commerce, Shakira and 4 other family members being casualties of its conduct.
21. Even in spite of the horrendous outcomes for Shakira, all requests have been ignored.
22. We are unable to establish now if Shakira has even seen paperwork that has been sent to the hospital in good faith that it would be given to her to read.
23. Meetings are being conducted and of the 5 people injured in this matter, referring to Elder Otto Sims, Ormay and 2 sons, no one is contacted or invited to meetings or discussions.
24. I am not invited.
25. We are working on housing solutions to accommodate a wheelchair and as a quantum upgrade of the current standards of housing fro First Nation.
26. This is all obstructed by these standards. And zero progress has been made.
27. We have ordered cards with Klarin; to travel to view the housing situation, and have innovative and evolutionary discussions of managing Trust account funds.
  - 27.1. That is, the Sovereign issuing instructions to the Trustee.
  - 27.2. **This has been ignored.**
  - 27.3. 'The Trustee is incompetent.
  - 27.4. **They remain on Order, for immediate access. Thank you.**
  - 27.5. **4 x \$10 000 cards for our team to travel and accommodate.**
