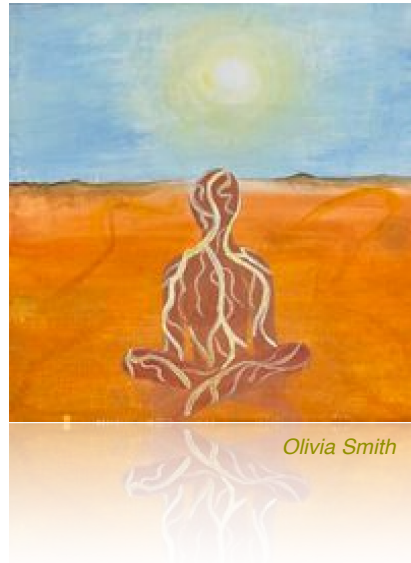

3. It has been determined by Elders in the **First Nation Sovereign Council**, Saturday 1 June 2024 that the following is relevant:
4. It is well known that no Treaty exists upon these Lands between the private corporation known as the Australian Government, and the First Nation People of these Lands known as Terra Australis - the actual Land mass.
5. We are well aware that the Australian Government is a fictional framework sitting over the top of the Land mass.
6. We, as Sovereign, those with breath,
 - 6.1. hold accountability to the corporation/s - that without breath;
 - 6.2. for the business it conducts on these lands without our permission
 - 6.3. without paperwork
 - 6.4. except that created by its own system of commerce.
7. Usually positioning itself as Landlord.
8. That position is a fiction and does not exist in reality.
9. Any claim of Landlord has come about only via genocide and ongoing assault in a variety of ways. Some obvious, others more subversive.
10. We are aware that commerce is derived from the use of the Birth Certificate as **receipt** for use of Resources.
11. However, because Humanity was placed under **Guardianship**, without Free Will and Informed Consent
 - 11.1. via the Papal Bull Unum Sanctum 1302, and many others to follow,
 - 11.2. such as the Doctrine of Discovery 4 May 1493 - 30 March 2023, 530 years.
 - 11.2.1. Now terminated.
 - 11.2.2. Via Pope Francis.

11.3. there does not exist any **Terms and Conditions** on the contract known as the Birth Certificate for what **Crown: We The People of Superior Jurisdiction** deem to be acceptable living standards on our abundant planet.

11.4. Therefore, as we deem the Guardianship to be a fiction, and to be terminated on mass.

11.5. As per the Inaugural Australian Grand Jury 23.9.2021.

11.6. And to exist only for the purposes of those who truly require Guardianship.

11.7. And to take instruction from the Sovereign at all times.

12. We hereby issue the following **Terms and Conditions** for all Resource Use on these Lands.

13. These **Terms and Conditions** may be upgraded at any time.

14. The Landlord is not the Australian Government.

14.1. A private corporation of a private globalist corporation.

15. No paperwork exists to substantiate such a claim.

16. The Landlord is, was, has always been, and will always be the First Nation People of these Lands.

17. That includes all those with breath in them.

17.1. Some ancient upon these Lands with Ancient say,

17.2. Others centuries upon these lands with worthy contribution of toil and Voice,

17.3. Others newly upon these Lands,

17.4. but with worthy Inherent Right to Resources,

17.5. as per all Humanity, all with Inherent Right to Resources, all over Mother Earth.

18. As **First Nation Elders**; We govern the Equitable Use of Resources, in conjunction with worthy and honourable Sentient Beings on these Lands, who's Ancestors may have found themselves as chattel cargo upon the tall ships, once upon a time, and have now perhaps resided here for multiple generations upon these Lands.

19. We offer no threat to these individuals or the homes they may have built by their own toil and goodwill upon these Lands.
20. Big Corporation however; is another matter.
21. This document pertains to Housing matters.
22. Community Housing: an asset, owned by **Crown: We The People of Superior Jurisdiction** and managed by the corporation called Community Housing, is recognised by **Crown: We The People of Superior Jurisdiction**, to be in varying standards of disrepair, thus contributing to the homeless problem.
23. The Australian Government is responsible for the maintenance of the assets, drawing the budget from the use of the Birth Certificate as bond for currency.
24. We appreciate that the US\$/Petro Dollar was retired on the 9th June 2024. And this does have repercussions upon cash flows. All Departments should be utilising asset back resources at this time to generate funding.
25. There is more than enough for everyone.
26. There is no issue to share the abundance of these Lands with the Greater Humanity who may have arrived in the past 236 years.
27. So long as that Humanity is behaving in 'right way'.
28. And causing no Harm and Injury.
29. Alas, that is not the case. Particularly from the Public Servant sector that chooses to enforce authority that does not exist.
30. These **Terms and Conditions** may be upgraded at any time.
31. We recognise the Land Titles to be fiction, existing without permission.
32. To have been laid out over these lands despite ancient pre-existing boundaries of hundreds of tribes upon these lands.
33. However, we do not offer disruption to housing based on those Titles. At this point in time.

34. Mitigating all trauma during times of prolonged trauma is a priority.
35. We recognise Native Title, under the approval of the privately owned Federal Court, to be inferior instruments and without weight in the matters of this day.
36. These instruments may or may not continue to be used, but only under matters of 100% transparency.
- 36.1. Such instruments currently cannot verify such a status, with hidden accounting and failure to disperse funds appropriately. Including, and as confirmed by ORIC, to be standards in all Prescribed Body Corporates,
- 36.2. No distributions were recommended, declared or paid to members during the year. The corporation is a non-profit corporation and its Constitution does not allow payments including dividends, bonuses or distribution of profit, directly or indirectly, to members officers, servants, agents or employees other than as reasonable remuneration for services actually rendered.*
- 36.3. The financial statements and notes, as set out: are in accordance with the Corporations (Aboriginal and Torres Strait Islander) Act 2006, the Regulations and the corporations constitution and :*
- 36.3.1. a. Comply with Australian Accounting Standards - Reduced Disclosure Requirements; and*
- 36.3.2. b. Give a true and fair view of the financial position of the corporation as at 30 June 2023 and of its performance for its operations as a whole and its individual grants for the year then ended.*
- 36.4. These are not acceptable standards of transparency, not equitable distribution of resources and are Null and Void.

36.5. First Nations have never ceded Sovereignty and certainly have no binding to:

36.6. *the Corporations (Aboriginal and Torres Strait Islander) Act 2006, the Regulations and the corporations constitution.*

37. Further, we issue Notice in this document that all buildings within the Australian Government stock holdings are Publicly owned.

38. The People are called the 'Public' in the private system of commerce upon these Lands; without permission or Lawful Due Process.

39. Great privilege has been taken by ignoring the Lore of Laws: the Lore of the management of the Land, Air, Water and Spirit.

39.1. That only those with breath can do.

39.2. A corporation has no capacity to manage the Lore of Laws.

39.3. Because it has no breath.

40. Both domestic and commercial buildings are the property of **Crown: We The People of Superior Jurisdiction**; having been built by the monetisation of the Birth Certificate.

41. We have paid for them. We own them.

42. We deem such buildings to be our assets. To be our stock holdings.

43. We are aware of houses being maintained in unacceptable standards of disrepair. And left vacant.

43.1. This is misappropriation of resources and

43.2. Mismanagement of Community assets.

43.3.And must be remedied immediately.

44. Many houses sit empty, for no good reason other than mismanagement and a fraudulent paradigm of scarcity.

44.1.Thus leaving mothers and children homeless.

44.2.Thus piling too many people into one dwelling.

44.3.Thus exacerbating stress and driving business into those commercial courts, jails and hospitals due to domestic unrest.

44.4.This is an unacceptable standard.

45. This is a mega billion dollar Land mass in financial terms of natural minerals.

46. To be projecting in any way a scarcity paradigm, is to be projecting at the People a psy-op, causing **Harm and Injury** via the **Board of the Guardians**.

47. **We see you.**

48. This is the exact opposite of what a Guardianship is supposed to do.

49. And therefore we may assess the Guardianship as incompetent.

50. We are aware and experience the devastation of homelessness, despite multiple homes being left empty.

51. We are aware of the drama and crisis that food and housing issues generate.

52. We are aware of the business model that fuels the courts, jails, hospitals, broken families that is brought about by the **'Scarcity Business Model'**.

53. Therefore as the Original and Traditional Custodians of these Lands, we attend the Department of Communities with the following matters in hand and **Authorise** all payments to all trades to ensure all properties are brought up to living standards.

55. Please refer to Annexures attached for addresses of homes and commercial buildings requiring attention for adequate use to be of the assets.
56. We are aware the Australian Government is not organised in its management of payments to meet needs in Community. It needs to get organised.
57. We **Authorise** all payments.
58. Failure to produce remedy in the face of need will be deemed incompetence, with appropriate parties dismissed from their positions.

59. As a Community, we are more than prepared to assist in the clean up process.
60. Keys are to be made available. Immediately.
61. To ease the devastations of the housing and homeless industry.
62. We will issue a document to reflect the relationship of the dweller within the dwelling, and file it with this Office, and our own Office.
 - 62.1. This Office of the Australian Government will not be listed as Lessor - that being a fraudulent claim.
 - 62.2. But will be listed as Public Servant Administrator.
 - 62.2.1. 100% liable and accountable to
 - 62.2.2. **Crown: We The People of Superior Jurisdiction**, at all times.
 - 62.2.3. Responsible for maintaining all matters of Community housing stock, and other, to excellent standards.
 - 62.2.4. That is currently not happening.
63. We Trust you appreciate the magnitude of putting matters back into 'right order'.
64. As a foreign entity upon these Lands, the 'Australian Government': a franchise arm of a global government, has enjoyed the abundance of these Lands, whilst perpetrating genocide and persecution against First Nation. Therefore; this document and the rearranging of critical business relationships and the management of Equitable Resource Use is now in the hands of

73.2. as the repercussions of the termination of the privately owned Rothschilds banking sector reflect the fraud of debt it created.
