3. You are a public servant, paid on the public purse.

4. We have addressed the Department of Planning, Land and Heritage on the instructions of Daniel Kickett.
5. You, and your Office,
 - 5.1. have misappropriated Mr Kickett's land into the Aboriginal Land Trust without Lawful Due Process.
 - 5.2. You have disrespected Mr Kickett's most fundamental right to choose his own Counsel, and conduct his own affairs, by refusing to engage in the matters on the table, unless it is directly with Daniel Kickett. This is to claim superior jurisdiction over the free will of Daniel Kickett. This is slavery.
 - 5.3. You have refused to engage in communications with Meretta Kickett, the heir to the land.
 - 5.4. And now you have issued a threat of Police violence against myself and Denise Chadwick, and inadvertently Meretta Kickett.
 - 5.4.1. Please be aware, that should that be actioned; the Common Law Sheriffs of the Sovereign Peoples Assembly will attend your office to escort you from the building.
 - 5.4.2. Your position will be publicly gazetted as terminated.
 - 5.4.3. And you may come before a Common Law Court of Superior Jurisdiction of 12 jurors; to be assessed for the Harm and Injury you are perpetrating against community, as they endeavour to seek remedy for missing assets.
6. Thus we have lost 8 months of development time to apply remedy to what has occurred with the land. That is :
 - 6.1. The land is missing from Daniel Kickett and is in the Aboriginal Land Trust.

- 6.2. The land, based upon the lease, is positioned to not be passed onto the next generations within the family clan. Thus leaving family members without land for the future.
- 6.3. You would recognise that a lease in which the government is the lessor is based in a failure of Lawful Due Process. These are stolen lands. The Government has no legitimate records of how it came to be the lessor of these lands.
- 6.4. The land is positioned to be a government commodity, along with the other 22 million hectares that are inside the Aboriginal Land Trust. (ALT), despite no Lawful Due Process to correlate the movement of the land into the Trust.
7. Thus we must view these terms of conduct as Elder Abuse. Prejudice. And wilful intent to deceive, coerce, isolate and maintain a grip on a parcel of land that has no accompanying paperwork of remuneration, or Lawful Due Process.
8. We have attempted to discuss the matter with your office on the occasions you have listed the dates for. Beyond our initial meeting; all these occasions have been ignored by you and your office. This is gross incompetence.
 - 8.1. As a Public Servant, paid on the public purse; you have no capacity nor privilege to ignore such important matters.
 - 8.2. Nor threaten Police action against the First Nation Sovereign, and/or his team.
 - 8.3. You are deemed to be incompetent in your role.
 - 8.4. This is the behaviour of a belligerent occupier of these lands.
9. The Remedy to these matters includes the following:

- 9.1. The lease is deemed Null and Void, in the capacity that Mr Kickett is not the lessee, but is indeed, the lessor.
 - 9.2. The entire 40 acres is reclaimed back under the custodianship of Daniel Kickett.
 - 9.3. Thus, this matter will be filed into Landgate, for the record.
-
10. Additionally, as a guest on these lands, the Australian Government is required to provide remuneration, for its use of the resources of Terra Australis to generate profit.
 11. Therefore, the Australian Government is required to provide the necessary funding, and/or resources to facilitate development on the 40 acres that is Daniel Kickett's land.
 - 11.1. A new house built on the block where the house that burned has sat in disrepair.
 - 11.1.1. The house requires a verandah to flow around it's entire perimeter
 - 11.2. Additional dwellings on the land
 - 11.3. Additional cultural community facilities, such as a stage.
 - 11.4. Initial facilities to grow food.
 - 11.5. There is a severe family trauma at this time, with a family losing their house and teenage son to fire. Facilities to accommodate them is immediately required, on this tribal land.
 12. An Order has been passed in the Terra Australis Grand Jurys that a failure to respond by any Public Servant within a government department does now earn the individual a \$5000 damages invoice. Because our time is not free. And writing and being ignored is a time waster to making progress on important matters.

For the individual, in their personal capacity, occupying the Office of any Public Servant role who fails to respond to Crown Executive Orders, the fine is \$5000 in gold and/or silver; and the individual is publicly gazetted for belligerence and slavery.
