matter is found to be based in unsubstantiated claims warranting accountability, as by the **Sovereign Peoples Assembly of Western Australia** (SPAWA) on July 30 2023; **Claim # 91714646**, in an 8 hour Common Law Hearing, and before a Jury of 13 individuals, in which all 11 defendants were found guilty of all 5 charges of:

- 1.1.1. Kidnap and Hostage
- 1.1.2. Torture
- 1.1.3. Human Trafficking
- 1.1.4. Slavery
- 1.1.5. Misappropriation of Resources.

- 1.2. Therefore, as example to all DCP offices throughout Terra Australis, the Busselton Office will be closed by Notice on the windows, and public gazette, and the assistance of the Australian Federal Police.

1.6. What say you Jurors?

2. Order #2: Closing the Perth Children's Court

2.1. Based on the fact that the President of the Children's Court; Judge Quail, was a defendant in the above named Hearing by **Sovereign Peoples Assembly of Western Australia** on July 30 2023, **Claim # 91714646**, and was found guilty by a jury of his peers, it does render the Children's Court to be a court based in a **failure of Lawful Due Process**, and therefore needs to be closed.

2.5. Such process will be made available as soon as possible within given assemblies, but by no later than September 1, 2023.

2.6. A template will be created by processes established by the SPAWA format to ensure rapid case management and remedy.

3.1. - 4.1. Ventia Security, and others. Orders from the 24th Terra Australis Grand Jury, by **Crown Executive Orders** (CEO) and any and all previous Orders, do stand as the highest Authority in Law, having passed through a qualified Jury process and may be used and quoted throughout Terra Australis to immediately terminate any alleged authority of the Department of Child Protection, and whereby any such claims of need for intervention by such a Department, is immediately, or as soon as possible, processed via a Court of Common Law, and a jury of 12 peers, for validity.

- 5.2. For rapid response, such a hearing may be convened by zoom, by any Common Law Assembly, adhering to the systems and standards established by **Sovereign Peoples Assembly of Western Australia**.
- 5.3. Assembly's are to organise a weekly hearing to process cases, particularly since the Quantum Audit is in process; as gazetted 31.7.2023 on the '**We The People Speak**' Telegram feed.
- 5.4. A blueprint will be made available for such a process, no later than Monday 21st August 2023, following the 2nd official National & International Common Law Sheriffs (NICLS) meeting, 12 August 2023.
 - 5.4.1. It is noted, this meeting will be alternate weeks to the First Nation Sovereign Council (FNSC) Meetings, to accommodate as many Sheriffs as possible, and so that matters may weave throughout, to witness what is required for safe and healthy communities, and then establishing the mechanisms to uphold the Orders passed by the FNSC, SPAWA, and CEO.
- 5.5. It is particularly noted that teenage male youth, in commonly broken families, and therefore may be lacking a father figure, are assigned a worthy mature

male mentor to guide and influence in right way of essential values such as 'do no harm', and the acquisition of skill set, to ensure being a contributing tribesman, and not a disruptor. Thus avoiding institutions such as Banksia Hill, and the exacerbation of further mental and emotional cruelty.

6. Order #6: Registrars

- 6.1. Within the private Statutory legal framework of the Australian Government which likes to refer to its **statute and legislation** as Law; perhaps more powerful than a Judge or Magistrate; is the Registrar who has the power to file your documents, or not, into the court system. Registrars are gatekeepers, time wasters and manipulators of fact.
- 6.2. Thus the Registrar is truly the one who decides how your matter may unfold in the court system based on whether you can file at all, or perhaps only half of what you want to file.
- 6.3. Across the Family Court, the Supreme Court, the Magistrates Court, the Federal Court, it is the Registrar who creates significant time delays and confusion. They are then protected from accountability within their own system for their disruptive actions.

- 6.4. Should one find the actions of the Registrar biased, or illogical, one is not able to speak to the Registrar to clarify matters; one must file a **complaint** instead.
- 6.5. A **complaint** is a tiresome mechanism used by the Statutory framework, across all areas of the private corporation that calls itself the Australian Government; when folks do not fit happily into the fictional debtor construct this private corporation has created to manage Humanity.
- 6.6. As Humanity is merely chattel within this system, a **complaint** is viewed as simply bleating and does not need to be taken seriously, if dealt with at all.
- 6.6.1. An example of such a misrepresentation of facts, by the Registrar, is matter 2138/2022 before the Supreme Court of Western Australia in which Registrar Nelson so severely interfered with what the Defendant was presenting, that the the actual hearing was a farce and resulted in a movement, by Master Sanderson, in favour of the bank of a \$1.5M dollar property.
- 6.6.2. A further example, at the Family Court, is an inability of the Principal Registrar, Leonie Forrest, to accurately read the documents submitted, and to consistently delete the entire submission based on false claims of inaccurate format.
- 6.6.3. Or, the Registrar at the Federal Court refuse to file the documents of kidnap and hostage of 14 year old Takara Markwell. Thus preventing the matter from being heard at all. Also the same by the Registrar at the High Court.
- 6.6.4. In the Matter of PER/CIV/1874/2021 foreclosure - The Registrar signed off on documents for the Corporate Sheriff. Was the filing sealed and sent to Landgate under Form 25, to ascertain that a true process had occurred, before eviction? No it was not.
