First Nation Sovereign Council: *Superior Jurisdiction*;

present the following **Terms and Conditions** for

This is the Sentient Sovereign Voice of First Nation.

A *corporate* Voice in Parliament, for First Nation, who have never ceded Sovereignty; can only ever be of *inferior jurisdiction*. *At no time*; should Parliament ever believe it has the **final** say on matters related to First Nation, or Resource Use, on these Lands of Terra Australis. This is the **Voice** and Council of First Nation, and all matters must be approved by this Council to proceed.

Statement from the FIRST NATION SOVEREIGN COUNCIL.

**Addressing misappropriation of resources by Corporate Giants,
with an intent to bring about a prejudiced outcome to the Lawful landscape
of Terra Australis by the Private Member Association that calls itself
the Australian Government.**

1. **BHP**: ABN 49 004 028 077 and **Rio Tinto**: ABN 96 004 458 404,
2. Here on these lands, mine these lands and harvest multi Billion Dollar Profits, with an insignificant amount distributed equitably.
3. Commerce continues on the lands, without permission from the Traditional Owners and Custodians, unless through an inferior instrument called Native Title, created by the Private Members Association (**PMA**) that calls itself the Australian Government and is on these lands without permission, without Treaty, without blessing and without Bill of Sale. For 235 years now.

5. This seems to be a subject that some hope initiatives such as a Voice in Parliament can rectify. That cannot, and will not, be the remedy to 235 years of genocide, stolen generation and land grab.
6. **BHP** and **Rio Tinto** did donate \$2 000 000 each to the Parliamentary machine: the tool of the PMA, to work in their favour by generating the YES campaign and the YES vote, which would put all the land under the jurisdictions of the United Nations: a global corporate, commerce construct. That will not be happening.
7. 'Australia' was a founding signatory to the United Nation in October 1945, one month after the end of World War II. This occurred without a referendum. And therefore has no standing in Law.
8. Thus, no permission exists for commerce to operate through the filters of this global construct, harvesting the resources and sending profits offshore.
9. True First Nation folks have no desire to have a Voice in Parliament and maintain their own Sovereign Voice of Superior Authority to the Australian Government at all times.
10. 235 years after initial arrival, the PMA has failed to establish fundamental business relations for equitable Resource Use with First Nation People.
11. The Australian Government is in a weak position to continue commerce; with no bargaining power due to past and present relations of Crimes Against Humanity and inequitable use of, and misappropriation of resources
12. \$2 000 000 donated by BHP and Rio Tinto; is a percentage of the profits of the mining of these lands, which occurs without permission, except via an instrument of *inferior Jurisdiction*, as it was created by the Occupier, and is called Native Title. This is a

conflict of interest for the First Nation People who have never recognised Parliament as the tool of decision making in this country, and yet mine these lands for profit.

13. The budget expended upon this campaign to influence the good people of Terra Australis, by such a prejudiced campaign, is enough to feed and clothe all the homeless and hungry of this Nation.
14. Therefore, as a result of such corporations spending the profits of the mining of resources of these lands to influence the vote of the Referendum in favour of corporatising and silencing the First Nation Sovereign Voice; the only mechanism protecting these lands from 100% corporatisation, BHP and Rio Tinto will each 'donate' 5 x that amount, a total each of \$10 000 000, to the First Nation Sovereign People.
15. Any other corporation that has donated, is liable for the same.
16. Any other corporation that wants to invest funds into the YES campaign, will also need to donate 5 x that amount to the First Nation Sovereign People, whereby a % of the funds will be used to present an unbiased Voice.
17. The remainder of the funds will be used to build industry and re-write all corporate contracts for Land and Resource Use, in alignment with equitable distribution of resources.
18. Such donations are due and payable immediately: to Yunaga Birni Co-Operative and its association of Tribal Elders around the Country, and with the First Nation Sovereign Council.

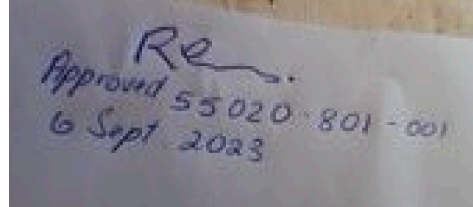

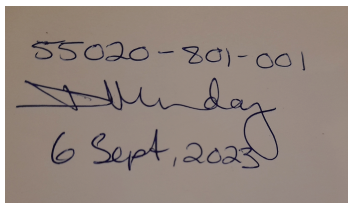
