2. Further to 55028-001-001, posted 8.10.2023 as Public Gazette upon this Office.
3. This Office of ~~Hon.~~ Sabine Elisabeth Winton MLA BA; BPS was officially closed by **Crown: We The People of Superior Jurisdiction.**
4. **Sabine Winton** failed to come when called to emergency matters regarding children, and the removal of, by **failure of Lawful Due Process.**
 - 4.1. That is: *The claimant must prove their claim.*
5. And consistently failed to allocate a time in the diary to discuss the matters, despite they pertaining to the removal of **First Nation** children from their clan.
6. First Nation have never ceded their Sovereignty to the Australian Government nor agreed to be ruled under the Statutory and Legislative framework, as delivered via Parliament.
7. Consequently **Sabine Winton** was found guilty of **Crimes Against Humanity x 5**, by **Crown: We The People of Superior Jurisdiction:** Court Hearing 30 July 2023;

in which 11 Defendants, none of whom appeared to defend themselves, were found guilty of **5 Crimes Against Humanity**.

9. The Minister for Early Childhood Education; Child Protection; Prevention of Family and Domestic Violence; Community Services, has been found to be **failing to fulfil this Title**.

10. It is known that Public Servants paid on the Public Purse were then told that matters of **Crown: We The People of Superior Jurisdiction**; processed before the highest authority on Planet Earth: a Jury, are matters of **'conspiracy'**.

11. And that matters of **Crimes Against Humanity**: the kidnap and hostage of children, should be dismissed as **'conspiracy'**.

18. Employees of this Office are advised to vacate their role within this Office. To exit the building and return home. And to standby for further instruction.
