18.7.Thus this is not a system of **Rule of Law: All Are Equal Before The Law.**

18.10. This is a **slave system**, and is easily identified as a **slave system** if folks take a moment to address the structure of the system. It is flawed.

18.11. Humanity entered the Guardianship **without free will or informed consent**.

18.12. **Therefore** it is also known as a **slave system**.

18.13. **Therefore**, in real **Law: All Are Equal Before The Lore/Law:**
we refer to a **structure** such as this as: **inferior jurisdiction**.

18.14. Because structurally; it is flawed in Lore/Law: as the essential basis of Lore/Law

18.15. **Inferior Jurisdiction** is the **corporate construct** that offers '**Corporate Immunity**'.

18.16. '**Corporate Immunity**' cannot protect you in Law. It is a **MYTH**.

18.17. It is a function that facilitates this system. It alleges to protect you if you move against
Maxim of Law.

18.18. But nothing can protect you if you move against **Maxim of Law**.

18.19. The '**corporate construct**' is a **privately owned legal system** and refers to

18.20. And writes policy through Parliament for the '**Public**'.

19. However: **Crown: We The People of Superior Jurisdiction** are not the '**Public**'.

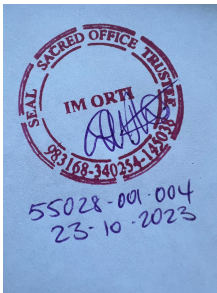
