14.2 Further to an **Independent Audit and Investigation** by the **Custodian/Creditor**, also referred to as **Crown: We The People of Superior Jurisdiction**; also referred to as the **Sovereign**, communications to the Public Servant sector, began 4 July 2022, in which **Instructions to Act** with regard to the Set-Off Accounting procedure were ignored. Despite <u>10</u> extensive communications. This matter moved to the **Energy and Water Ombudsman Western Australia 28 March 2023. Matter # 2023 - 00364** 

A further <u>17</u> communications have been delivered to the Ombudsman and associated Energy related departments. All Instructions to Act have been ignored, thus indicating the Custodian/Creditor cannot be seen, nor heard. Thus our Inherent Right of Use of Resources are under Belligerent Occupation and the Custodian is enslaved into working to generate privately owned currency to pay for access to our own Resources. This is slavery. Criminal Code 270: 25 years jail. The following penalties have been passed by the Terra Australis Grand Jurys to hold personal liability and accountability to those who trespass upon the safety and wellbeing of the Custodian.
