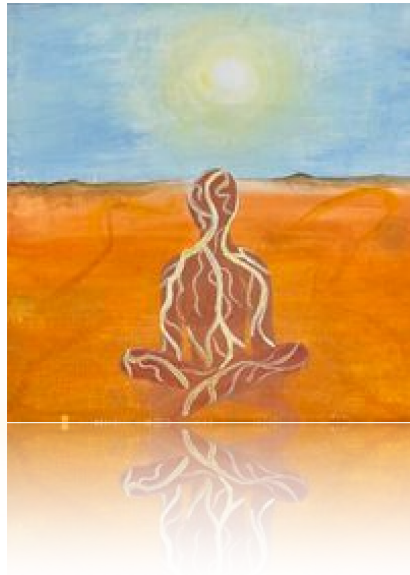

9.4. Reconfiguring the Master Trust: Unum Sanctum 1302.

9.4.1. To reflect freedom, not slavery.

- 9.5.4. The beginning of Humanity as the **Creditor**: The Executor and Beneficiary, accessing Inherent Right to Resources via the use of **competent** Trustees, using the Set-off process.
- 9.5.5. Currently there are many incompetent Trustees as they struggle to comprehend the changing of the structure of the Master Trust, and the loss of power as Guardianship is replaced by the role of the Executor.

9.6. Set-Off:

- 9.6.1. The action of issuing instructions to the Trustee, from the position of the Executor and Beneficiary, to accept the use of Inherent Right to Resources, via the Statement provided, and to balance the Ledger of debt: - map of resources used, against Creditor - Inherent Right to Resources: authorising use, management and recording of such Use. Thus bringing financial matters to zero, whilst also accurately recording Resource Use.
- 9.6.2. Such instruction may be issued via the Executor and Beneficiary letterhead, clearly identifying the jurisdiction of the Sovereign.

9.7. Inherent Right to Resources:

- 9.7.1. 9.8. Positions within the Trust to support Humanity as the Creditor:

9.8.1. The Public:

- 9.8.1.1. inside the Private Operating System of Commerce: (POSOC), Humanity is labelled as the 'Public'.
- 9.8.1.2. And via the privately owned Statute and Legislative framework of Parliament, is positioned to be the debtor.
- 9.8.1.3. Humanity, also called the People; are not the 'Public', and are not the debtor.
- 9.8.1.4. The concept of the 'Public' serves the purpose of being a **tool in commerce**, and is a legal fiction entity to move around a commercial construct.
- 9.8.1.5. Everyone has a 'Public' and it is managed by the Executor and Beneficiary, also known as the 'Private'.
- 9.8.1.6. Every individual is also the Executor and Beneficiary. If they choose.

9.8.2. Executor:

- 9.8.2.1. The highest position for 'Individual A' to occupy with regard to managing their inherent Right to Resources.
- 9.8.2.2. ***The Meek Shall Inherit The Earth*** Matthew 5:5.
- 9.8.2.3. Individual A : should hold the Executor position for themselves. No one else should hold this position for another, unless they choose for that to happen, or if they need for that to happen.
- 9.8.2.4. E.g. there is a genuine need for Guardianship.
- 9.8.2.5. In which case another Individual: B, of implied Trust and Integrity, would occupy the position of Guardian, or Power of Attorney, to make sound

decisions, in best interest, for Individual A. And would be responsible to ensure Inherent Right to Resources were delivered to Individual A.

9.8.3. Beneficiary:

9.8.3.1. The Individual receiving the benefits of access to the Inherent Right to Resources within the Trust.

9.8.3.2. That Individual should also be Individual A.

9.8.3.3. And may be other individuals too, as per instructions by the Executor.

9.8.3.4. If there is a need for Guardianship, Individual B would be responsible for ensuring Individual A receives the benefits of access to the Inherent Right to Resources within the Trust.

9.8.3.5. And thus ensures no unnecessary Hardship is experienced whilst on our abundant Mother Earth.

9.8.3.6. The evidence of Inherent Right to Resources, is the body.

9.8.3.7. The Body is here upon the Earthly plane and requires food and shelter and the freedoms to explore Mother Earth as needed.

9.8.3.8. Therefore the enclosure of Resources within a privately owned instrument such as Unum Sanctum 1302, and creating a Statutory and Legislative framework to charge for access to Inherent Right to Resources is a framework of **Slavery**.

9.8.3.9. And is therefore **terminated** by the **Divine Creator Source Energy** that always seeks to balance the energy field. This is evidenced by the mass movement of Humanity who have witnessed the slavery; and move against it to restore balance.

9.8.3.10.5. **The Meek Shall Inherit The Earth.** Matthew 5:5

9.9. Trustee:

9.9.1. The Individuals responsible for accessing the Trust, under the direction of the **Executor**, and moving the Resources into the correct positions so that the **Beneficiary** has access to the Resources.

9.9.2. Example of Trustees are Judges, Magistrates, legal practitioners, schools staff, teachers, doctors, hospitals etc.

9.9.3. Many of these roles will be repurposed to reflect the Executor/Creditor instructions.

9.9.4. Trustees have been occupying the position of Guardian whilst Humanity has been under a collective Guardianship, within the Master Trust of Unum Sanctum 1302. And thus, this is the restructuring of the Trust, to accommodate these evolutionary changes to the Consciousness of moving from the **debtor** position to the **Creditor** position.

- 9.9.6. Their primary handicap is that they are under an outdated jurisdiction of Guardianship.
- 9.9.7. The systems are used to deliver a 'scarcity' paradigm. Not an abundance paradigm.
- 9.9.8. Hence all systems are in a **perpetual Independent Audit and Investigation** until they are corrected to reflect the **Creditor**.

9.10. **Creditor:**

- 9.10.1. The **Creditor** is the Source of the Life Force that has been monetised for the purpose of the development of systems on Planet Earth.

9.13.1. Thus in this evolution, the debtor ledger is now balanced against the Creditor Ledger and all debt returns to ZERO. Simple.

9.13.1.1. The Creditor is the **Sovereign**.

9.13.1.2. With breath in the body.

9.13.1.3. The Living.

9.13.1.4. With Inherent Right to Resources.

9.14. Orders:

9.14.1. Those instructions given to the Trustees, by the Executor, to execute the Trust in a particular way, to access Resources.

9.14.2. The criteria for Use of the Resources within the Trust, cannot be governed by the Trustee, but are governed by the Executor adhering to Maxims of Law for effective Resource Management with intent to develop evolutionary standards for Humanity and may involve many forms of asset development: both tangible: e.g. housing, and intangible: e.g. travel, research, and further education.

9.15. The Birth Certificate: a tool in commerce.
