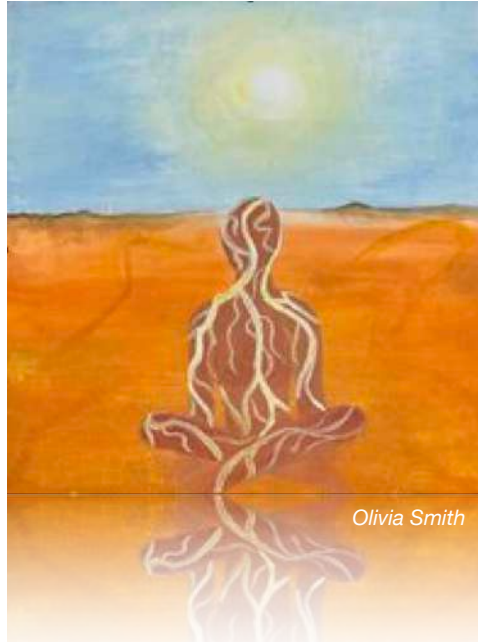

5. Notice 2025-833-007, FILED 11.12.2025; records multiple un-rebutted Defaults, non-response, and explicit instruction that the prosecuting entity was to withdraw due to jurisdictional and procedural failure.

8. As per 2025-833-005, it was clearly identified that this matter raised by The LEGAL PRACTICE BOARD of WESTERN AUSTRALIA - a State corporation, coming before a State Court, was a clear conflict of interest, where both parties performed by Oath to same employer.
1. Therefore, an unbiased outcome is an impossibility.

7. FAILURE TO READ GOVERNING MATERIAL

1. Incapacity to Function

1. Governing material controlling whether the forum could lawfully proceed had already been filed.
2. The requirement to read that material before proceeding was explicit.
3. The Office proceeded regardless.

2. Finding:

1. Failure to read governing material is incompetence.
2. It disables competent function.
3. Proceeding in that state constitutes continuation without authority.
4. And renders outcomes **Null and Void.**

8. ASSISTANCE TO AN ENTITY IN DEFAULT AND DISHONOUR

1. Institutional Complicity

1. As at 12 December 2025, the prosecuting entity was already recorded as in Default and Dishonour under 2025-833-007.

10. It was a **diagnosis of the act that had just occurred**.
11. The loss of free will; the inherent right to be heard and choices acknowledged; the second pillar of Lawful Due Process, was ignored.
12. Thus rendering the Court incompetent and facilitating
13. The movement of the matter in the direction of the PROSECUTOR.
 1. Already in profound Default and Dishonour.
14. Whereby, a corporation, alleging to have jurisdiction over the Living, a jurisdictional impossibility; just moved one step closer to incarcerating a Mother and a Grandmother; two Wise Elders in Community.

 1. People in jail, on remand.
 2. That is, jailed before being found guilty.
3. **Maxim of Law: Innocent until proven guilty.**
4. Such remedy is not limited to this statistic.
3. This is clear and undeniable evidence that this Office is operating as a Human Trafficker. And does generate revenues for all corporate services associated with the incarceration of Humanity in the private jail systems of 'Australia'.
4. 'Australia', an offshore corporation, is occupying our Land of Terra Australis, without Lawful Due Process as evidenced in 2025-833-008.

17. Why "Not Guilty" Does Not Reduce the Harm

1. The plea entered was "Not Guilty."

1. This AUDIT records that the content of the plea is irrelevant.

2. The harm is not *what* was pleaded.

3. The harm is that anything was pleaded at all.

2. Thus, by entering a plea, the Magistrate enters into the game those who had astutely recorded that they were attending as Superior Jurisdiction, and were not there to engage in the game, but to bring remedy to the matter.

2. That is; the matter is **Discharged and Dismissed with prejudice**; based on jurisdictional failure and by uncured **Defaults and Dishonour**.
3. The Magistrates Court will erase the hearing scheduled for February 17, 2025, and list the matter as **Discharged and Dismissed with prejudice**.
