

- 2. Respectfully, and with great opportunity;

- 1. You are being re-purposed by the Restoration of Law and Lawful Due Process.
- 2. Please refer to the above Maxim of Law for Right Order and Right Way.
- 3. Please read it several times and ensure you have clarity on Right Order.
- 3. That being said, you are to withdraw your claims from the Magistrates Court immediately, based in the following: **IGNORED** 
  - 1. Jurisdiction; and the crossing of.
  - 2. Defamation.
  - 3. Default and Dishonour.
  - 4. You will need to cancel all records that have 'Criminal' attached to our names.
    - 1. IGNORED
  - 5. That is defamation of character.

  - 3. And a multitude of other times, the jurisdiction is identified.
  - 4. And IGNORED.
- 8. You have not rebutted anything we have given you.
  - 1. And therefore it has standing in Law.
  - To continue as you have puts you and your organisation into Default and Dishonour. IGNORED
  - 3. You do not come to Peace in Equity. You go to War.
- 9. You have not provided the documents we requested in our last communication: 2025-833-005 2024/3547.
  - 1. Points 17-20 are required **IGNORED**
