

- 3. Plausible deniability is a wilful intent to deceive and will be noted if used.
- 4. Our presence does not concede jurisdiction to the Statutory system at any time, or in any way.
- 5. Nor any presumption that we are statutory "legal practitioners".
- 6. We attend under duress due to threats made by a Statutory Corporation of inferior jurisdiction.

2. Discharge by Superior Jurisdiction

- 1. Two jurisdictions are present.
 - 1. Inferior: The State.
 - 2. And Superior: The People.
- 2. Crossing jurisdictions is forbidden.
- 3. The CLAIMANT is a statutory corporation of inferior jurisdiction; the RESPONDENTS are Living Women of Superior Jurisdiction.
- 4. A statutory corporation cannot prosecute the Living.

- Accordingly, the entire matter has been DISCHARGED by Superior Jurisdiction for want of lawful authority, un-rebutted Defaults, crossed-jurisdiction violations, and procedural Dishonour.
- 6. No lawful step can follow from this point forward.
- 7. Refer to Terms and Conditions in 2025-833-008, Long form.
- 8. Nothing the Court says or does can progress this matter beyond 12.12.2025.
- 9. No document can be issued to encumber the Living without the Statutory bodies being held accountable for slavery.

3. Grounds for Discharge — Seed Event, Fully Revealed

- 1. The entire claim arose from a single lawful act:
 - 1. Mr James Dargin requested that we record his instructed words as he was one day before a mediation for damages for his matters as a sexually violated child in a State Orphanage. His word had not been discussed or recorded of what he felt was acceptable remedy for his life time injuries from those experiences.
 - 2. We acted as lay scribes, not as legal representatives.
 - 3. We did not hold out as lawyers.

- 2. James Dargin confirmed, in writing, to the Sisters of Mercy and the State of Queensland:
 - 1. we were not his legal practitioners;
 - 2. every word and figure was his;
 - 3. he authorised us to record his instructions.
 - 4. We exchanged no payment in assisting James.
 - 5. We were Community helping Community.
 - 6. Refer to Annexes 2 and 3 for written testimony by James Dargin that we did not engage as Legal Practitioners of the private BAR Guild.
- 3. Therefore, the allegations under S10 and S11 were void by mischaracterisation.
- 4. The charges are **Discharged.**

4. Jurisdictional Impossibility

- 1. The CLAIMANT operates in Legal,
 - 1. that is the language of the State,

- 4. Maxim of Law is Law and exists inherently in the landscape.
- 2. Inferior Jurisdiction: Legal, cannot bind Superior Jurisdiction: Law.
- 3. Maxim of Law: Acts without jurisdiction are nullities and produce no lawful consequence.
- 4. The claim collapsed at inception.
 - 1. But has persisted for 533 days.
 - 2. This is a clear act of violence against the People.
 - 3. Individuals are accountable.
- 5. Personal Liability (Motu Proprio 2013). Pope Francis.
 - Corporate immunity was extinguished in 2013; all Officers are personally accountable.

- 2. The LPBWA Board consists of 45+ living men and women hiding behind a corporate veil.
- 3. All continue in this matter after Notice, and thus in full personal liability.
- 4. Each Board member is responsible for the harm, trespass, and crossed-jurisdiction violence pursued against the Living.
- 5. Refer to time sensitive details in 2025-833-008.

6. Standing Defaults — Nine (9) in Total

- 1. the CLAIMANT and associated Offices remain in nine (9) uncured Defaults.
- 2. Across Notices:
 - 1. 2024-833-001,
 - 2. 2024-833-003,
 - 3. 2025-833-005,
 - 4. 2025-833-006, and
 - 5. 2025-833-007,

- 3. All material points remain un-rebutted.
 - 1. Silence created **Dishonour**, perfected by **2025-833-007**.
- 4. Un-rebutted claims stand as truth.
- 5. **Dishonour** collapses jurisdiction.

7. Conflict of Interest

- The LPBWA and the Magistrates Court share the same State-owned structure and lineage.
- 2. A private statutory guild prosecuting in a private statutory enforcement forum is a fatal conflict.
- 3. It is an "unbiased impossibility."
- 4. Such a forum cannot adjudicate upon the Living.
- 5. The charges are **Discharged.**

8. 533 Days of Threat & Harm

- We have been under ongoing threats of imprisonment and fines for 533 days 28
 June 2024 12 December 2025.
- 2. This has been oppressive and harmful.
- 3. Damages are particularised in Annexure A.
- 4. And are due and payable now.
- 5. By Public Liability Insurance Policy.

9. Notice to Security / Police / Court Officers

- 1. No officer is to touch, restrain, escort, or detain either Living Woman.
- 2. Any such act is recorded as personal violence without lawful authority.
- 3. Liability attaches immediately and individually.

10. Magisterial / Justice Office in Continuing Dishonour

1. The Magisterial Office and Justice Department stand in the same factual position:

- 1. both are State-run, statutory, inferior-jurisdiction constructs;
- 2. both rely on presumption rather than Law.
- 2. As demonstrated in Annexure A 2025-833-008; the State has 19,000+ people on remand, that is: jailed before proven guilty
- 3. This is a systemic violation of:
 - 1. Maxim of Law: Do no harm
 - 2. Maxim of Law: The claimant must prove their claim
 - 3. Maxim of Law: Innocent until proven guilty
 - 4. Immediate remedy must be engaged to dramatically reduce this number to only offenders of potential serious and violent crime, awaiting trial.
- 4. A forum producing this level of harm stands in procedural **Dishonour of its own**Oath.
- 5. A Statutory system cannot sit in judgment over the Living.
- 6. The forum stands as an:
- 7. OFFICE IN CONTINUING DISHONOUR, UNDER LAWFUL DUE PROCESS AUDIT AND CORRECTIVE OVERSIGHT.

11. Procedural Boundary (Recorded)

- 1. The Friday mention constituted the procedural boundary.
- 2. Any continuation after Notice, Default, Dishonour, and jurisdictional failure constitutes:
 - 1. fraud by presumption
 - 2. corporate violence against the Living
 - 3. attempted slavery/guardianship under colour of authority
 - 4. The matter therefore can not/could not lawfully advance.
 - 5. The charges are **Discharged.**

12. Final Statement

1. This matter is **discharged** by Superior Jurisdiction.
