

13. Maxim of Law: Where consent is absent, coercion constitutes injury.

1. Application: Detention threats absent consent and lawful authority constitute coercive injury.
2. To a willing person, no injury is done — therefore without consent, injury is done

8. Bar to Proceeding: Purported Hearing of 17 February 2026

1. Notice of Bar
2. Any purported “hearing” or listing dated 17 February 2026 is barred due to :
 1. unresolved identity/authority
 2. and the recorded **Default** and **Dishonour**.
 3. **And Maxim of Law:** No one should be a judge in his own cause.
 1. A person or body cannot lawfully assert jurisdiction, determine its own authority, and enforce consequences arising from that assertion without independent and lawful standing.
 2. **Application:** Where a body claims authority: LPBWA : State entity, prosecutes, adjudicates, and enforces within the same process: Court: State entity, detention threats are void for want of lawful jurisdiction.
3. It is not possible to proceed to a case whilst the Authority remains unverified.

4. Magistrate Walham remains accountable for :
