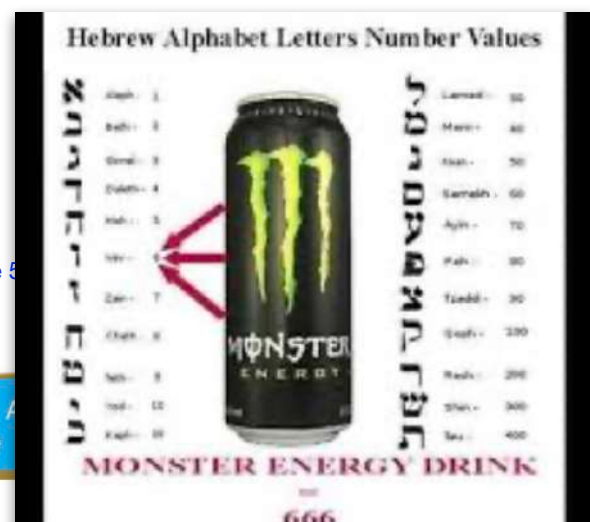

5. **Natural Law 005: Sheriff Council Sentence** (for child/teen) — Formal assignment of restorative obligations.
6. **Natural Law 006: Sheriff Council Sentence** (offending parent) — Declaration of domestic violence by proxy and conditions of remedy.
7. **Natural Law 007: Community Sheriff Ledger** — Permanent and sacred record of harms, testimonies, and remedies.
8. **Natural Law 008: Consecration Ritual for the Ledger** — Ceremony anchoring the Ledger in 111 Divine Order.

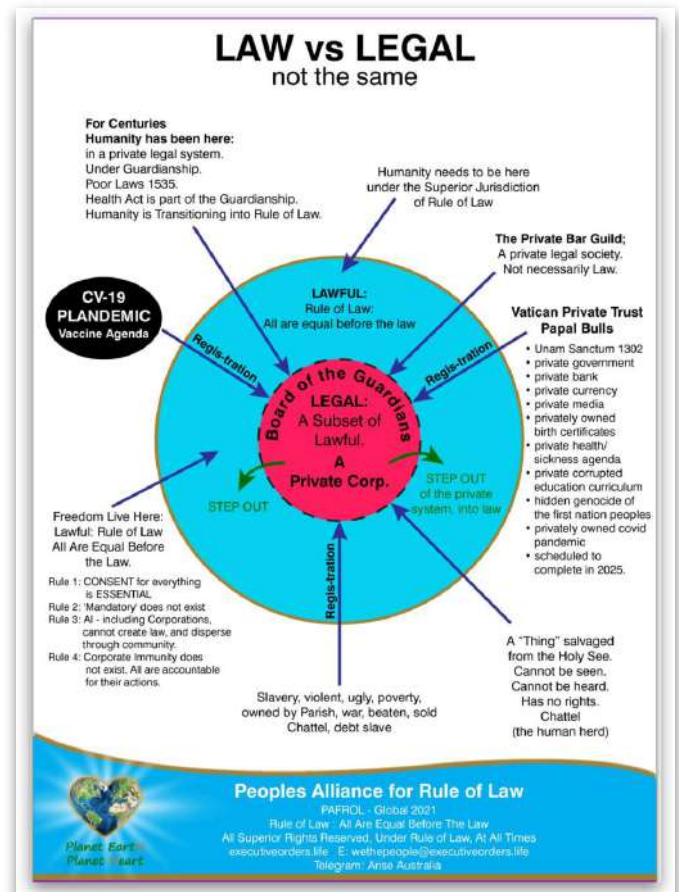
