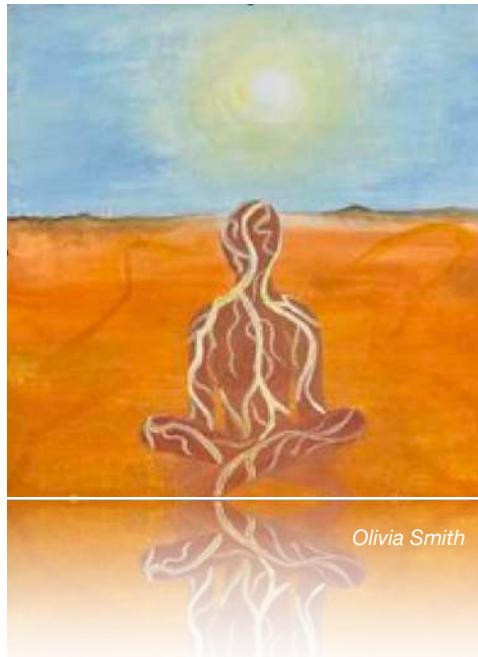

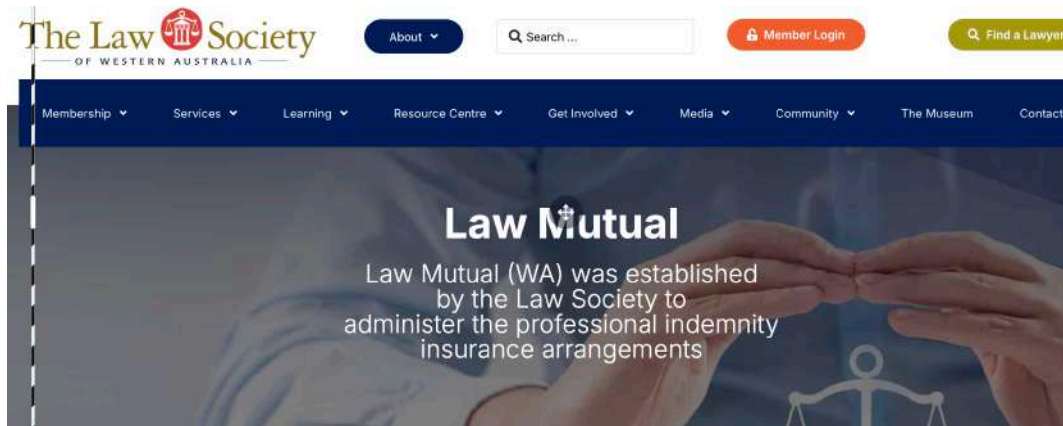
1. Emma and Jerald Martin were each incarcerated for 30 days based on Orders that were written in a mistrial, as the defence was blocked from being filed.
