All words and meanings here/within are-as, I, :Denis-Peter: defines them, Non-obstante.

(1) For the record:

All words, meanings, layout and format, here/within are-as, I, Suv'eran :Denis-Peter: ⁽ⁱ⁾ also referred to as :Denis-Peter: ⁽ⁱⁱ⁾ ... Settlor ⁽ⁱⁱⁱ⁾ ... the living man ⁽ⁱⁱⁱ⁾, and attorney-in-fact ^(iv) [for all purposes related to the administration of the living estate], defines them, Non-obstante, and furthermore, please remain aware, there is, no-statutes-of-limitation on crimes of fraud, or on crimes of committing harm to others, [living men and women], either-way, this is a formal complaint and demand for action;

(4) Regarding:

The following claims no made: the crime of Personage; the crime of fraud; the crime of threats and intimidation: to the living man;



(5) My belief and claims:

Having received a threatening payment reminder, that ERGON ENERGY personnel and actors, for the retail and operations team; have claimed the assumption I :Denis-Peter: have an outstanding debt, using a fictitious name construct, D RAWLINSON, ^(v) [all upper case] then going on to state Dear Rawlinson, continuing on to using threats and intimidation, thereby assuming I :Denis-Peter: the living man is property ^(vi); claimed by using some fiction name construct to create a joiner to the living man, thereby committing the crime of personage ^(vii) being a fraud, and then to stoop to the level of threatening to disconnect an essential supply, that could possibly set in motion episodes leading to the increase of a life threatening event, due to a recent heart attack, I :Denis-Peter: only recently recovering from, [were now more than ever, I need this essential supply, a right that cannot be denied by a corporate body that serves living men and women – who’s taxes, paid for the construction of the power system, and other essential supplies and services for the good of the people] “and most certainly not for the good of corporations” that is now run by greedy conglomerates, and share holders, at the peoples expense;

(6) The result of these threats:

This over abuse of assumed power, never granted to you all, by the people,; has led me to research and investigate your roles in the lives of living people, and has brought to light some very fraudulent and immoral acts against the people, were corporate bodies have set themselves up as masters over the people with the use of personage; [this also included the assumed state and federal governments, that are no longer de-jure, but also are corporate bodies standing in treason]; with all their attached registered business, with share holders, racking in money from the people, they are suppose to serve;

(7) My investigation has found:

That the ERGON ENERGY being just an entity, [that cannot deal with the living without, freely given consent] ^(vi) ... is regulated by the Australian Securities & Investments Commission, with a registered name : ERGON ENERGY CORPORATION LIMITED , an Australian Public Company , ABN 50 087 646 062; with a registered office in ; TOWNSVILLE QLD 4810, controlling and running an essential supply for and by the people of Queensland Australia, and further investigation has led me to how you are; either being used or allowed by the State government, to usurp money from the people, or [are doing so for your own gains], and this is being done through fraud, [of which I now have the evidence], it is done by committing the crime of personage, and on the assumption, the people will not find out about it, but go along with it totally unaware, unbeknown [as I was] – that they are partaking in the crime of fraud, “though absolutely innocent of the crime” due to the failure of the fraudsters to give full open disclosure ^(vii), thus making any and all assumed contracts null and void; and thereafter open to full restitution and compensation [Cure and remedy], this revelation, now made sense why a fictitious word construct [D RAWLINSON] using dog Latin was used, and could not be changed to represent the true name of the living man, as corporations need freely given consent by the living, but only after giving full open disclosure of the contract, and the signed off by both parties, this being a fact that was never done between I, the living man :Denis-Peter: and- ERGON ENERGY/ ERGON ENERGY CORPORATION LIMITED, [I feel I would not-



be wrong to believe other people such as I using ERGON ENERGY/ ERGON ENERGY CORPORATION LIMITED, could also be subject to this fraud], and that would be one very gigantic fraud, also;

(8) Yet more ongoing research was also carried out:

Which I have not completed yet, however what I have to date; everything is pointing to the fact that I, the living man :Denis-Peter: have been trafficked, in modern day slavery, subjected to crimes of personage that have been carried out against I, :Denis-Peter: by fraudulently constructed names of which three sections have now come to light; these fraudulently created public trusts using the [all upper case construct of a name with the surname] from the fraudulent birth certificate; supplied by the state, are being used fraudulently to usurp from the living estate [from my trust]; and these names [being personas, persons or legal fictions] are written as shown, "that also show which group they belong to";

Normally there are three, all containing the "surname", though now sometimes in lower case, [were the attachment of the "surname used" is the fraud];

- (a) DENIS PETER RAWLINSON = Municipal Cestui Que Vie Trustm,
- (b) DENIS P RAWLINSON = Public Transmitting Utility,
- (c) DENIS RAWLINSON = Public Charitable Trust

But here we have a fourth: that is showing as D RAWLINSON, obviously designed to usurp wealth from the living estate of :Denis-Peter: house of Rawlinson, or just outwardly commit theft; A double dip, having the living man also pay for that which has been discharged, - were another crime is being committed by the usurpers, of evading Tax, for the extra profit made by ERGON ENERGY CORPORATION LIMITED and its actors, directors, and share holders, along with the Minister for power (QLD), whom are usurping wealth they have no right to, and not reporting to the security exchange; hoping it will never be found out, for if the payment is made by the unsuspecting, that were never informed of the crimes being committed against them, [as I was through lack of knowledge, that now I, the living man :Denis-Peter: have found out] and the crime of withholding full disclosure; "then that is fraud", and a crime against mankind, violating Gods law; with further crimes, when you engage the unscrupulous BAR association, to go after the living men and women, to keep the fraud alive to feed the beast, both are then culpable of committing battery against the living man and woman, of which, ERGON ENERGY CORPORATION LIMITED and its actors, directors, and share holders, along with the Minister for power (QLD) are then accessories to the crime committed by the BAR association they engage;

Therefore as D RAWLINSON; in no way correlates with the fraudulent birth certificate; or a name that would have been given by I, :Denis-Peter: the living man, and the fact ERGON ENERGY/ ERGON ENERGY CORPORATION LIMITED and its actors, have taken it upon themselves to attack and threaten I, :Denis-Peter: under a fraudulent name, committing personage, and the further use, of addressing the living man in a lower case "surname", being the height of disrespect for a man or woman, showing they are being claimed as property, by assuming control over the person, causing harm;

(9) Therefore:

ERGON ENERGY CORPORATION LIMITED, and board of director as well as all actors, and the energy minister, are here in this now time on notice, as it's a crime to conceal a crime, and a fraud to conceal a fraud, also;



(10) Therefore as of now:

All the actors, and particularly the author or authors, of the attached threatening “payment reminder” containing threats and intimidation, sent to the living man, :Denis-Peter: house of Rawlinson, - using a fraudulent attachment resembling a name D RAWLINSON, and going on to state “Dear Rawlinson”; and sending a Payment Reminder using threats and intimidation to the living man, without a name and signature of the authorised one making the claim; with just these three actions (fraud has been committed, as well as the crime of personage); for at no time was either of these claimed names or formats ever supplied to ERGON ENERGY/ ERGON ENERGY CORPORATION LIMITED; as I have only two names, the one within the living soul, being I-Am, the other being the name on the source document [attached] showing who I-Am, that was hand written by the living, where I-Am was granted the name “Denis Peter”, and though the state did supply a birth certificate [nothing more than a security instrument] registered ten days later, (copy attached) showing the true name once again, Denis Peter, written in plain English, not all upper case glossa or dog Latin; proving I, was not a legal fiction, persona, or a person, yet the state took it upon itself to force upon I, a surname, [without full open disclosure as to why] yet I was forced to use it, [that was a fraud], by the very act of the attachment of a surname, to create the public trust, done in all upper case construct; which do not conform to any English styles manuals, and is a fraud; as any claimed name in all upper case, used against the living: is CAPITIS-DEMINUTIO = it being the highest and most comprehensive loss of status; [which occurred when a: man's or a woman's condition, is changed from one of freedom to one of bond-age: when he or she became a: slave; and has all of their rights swept away; their God given rights; their Inherent rights; their Indissoluble rights and Natural rights; violating, Gods Law; trust law and equity law];

(11) Therefore all those named within:

Are requested without delay, to truthfully answer the following question under oath under the pain and penalty of perjury: all questions must be answered, and factual evidence supplied to prove the claim:

- I. Who is D RAWLINSON?
- II. Does any factual evidence exist to show, who D RAWLINSON is?
- III. Is there any documents supplied, or in existence, that shows :Denis-Peter: the living man, did hand write or print on any documents, D RAWLINSON as the name for Denis Peter with a family name of Rawlinson? If so factual evidence is required;
- IV. If the actors and directors of ERGON ENERGY/ ERGON ENERGY CORPORATION LIMITED, believe I, the living man Denis Peter as shown on the source document when born, and later shown as Denis Peter [on a birth certificate supplied by the state] ... and a name construct in all upper case that was created by the actors for ERGON ENERGY/ ERGON ENERGY CORPORATION LIMITED, ... [that name being] ... D RAWLINSON ... are indeed one of the same ... then factual evidence under oath and pain and penalty of perjury, is to be supplied without delay to: Suv'eran :Denis-Peter: At, 136, Martin Crescent, Queensland, [4314] Australia; in the private;
- V. Is D RAWLINSON a trading commodity or a created security instrument?
- VI. What is the CUSIP N^o attached to the D RAWLINSON?

All questions must be answered, truthfully under oath, backed by irrefutable evidence, also;

(12) Remedy;

Therefore, should ERGON ENERGY/ ERGON ENERGY CORPORATION LIMITED and its actors, fail in answering any of the questions within, including rebutting statements made, that must contain irrefutable facts and evidence, supplied under oath, within no less than twenty one calendar days (21) from date of recorded postage of this notice ... Then for the act of threatening, intimidating, committing the crime of personage, committing the crime of trafficking, committing fraud, assuming authority never granted, and being disrespectful, It will then be required that the following is carry out instantly and be completed within "seven day (7)" of failing to answer all questions, and supply, by registered post ... I :Denis-Peter: the living man:

A certified true copy of the contract that exists with Denis Peter of the family name Rawlinson, A certified true copy of full disclosure of that contract; [both shall contain name and autographs of both parties, and;

ERGON ENERGY/ ERGON ENERGY CORPORATION LIMITED, must produce evidence, and proof of claim that, I Denis Peter of the family name Rawlinson, must pay all claims made against D RAWLINSON and accept all liabilities for that name [be it upper case or lower case, or capitalised], becoming the property of ERGON ENERGY/ ERGON ENERGY CORPORATION LIMITED, and;

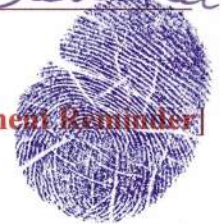

- i. Suv'eran :Denis-Peter: the living man with appellation, when dealing with the public;
- ii. Denis-Peter: The living man without appellation, on record; I.C.L.C : Ref: BC/19/18074 = Claim of life, the living man. (Deed);
- iii. Settlor: a person who makes a settlement, especially of property in establishing a trust, a fact that is already in progress, and on record; I.C.L.C. Ref:
- iv. Attorney-in-Fact: for all purposes related to the administration of the living Estate, therefore all correspondence should be addressed to, Suv'eran :Denis-Peter: At, 136, Martin Crescent, Queensland, [4314] Australia; in the private."
- v.
