(ABN-89972463351; DUNS-757803718); 45 Glendon Street, Kingaroy, Queensland 4610, Australia; furthermore this also includes, the Hon Dr- Steven Miles (local government minister): and the assistant local government minister, and the Minister for Queensland treasury, as well their heirs, successors, nominees and assignees; for the QUEENSLAND STATE GOVERNMENT ABN: 75 818 456 675, 33 Charlotte St, Brisbane City QLD 4000, Australia, therefore;

(4) Equity aids the vigilant, and not those who slumber on their rights; The Claim:

I :Denis-Peter: here and now accuse those named within, clause (3) page 1 of 4; in both their acting roles as well as in their private capacity; including the claimed-local-government-named-entity, the SOUTH-BURNETT REGIONAL COUNCIL. (ABN-89972463351; DUNS-757803718); of knowingly and intentionally violating the Securities Exchange Act 1933 and 1934 – NYSE; of which the, QUEENSLAND TREASURY CORP CIK#: 0000852555, Come under, being a section of the QUEENSLAND government and an active complicit team player, of all claimed-local-governments, within QUEENSLAND, and being fully aware of these crimes being committed against the people, I: Denis-Peter: of the house of Rawlinson, being one of them, therefore;

(5) Equity will not allow a statute to be used as a cloak for fraud; The wrongdoing committing harm:

I: Denis-Peter: of the house of Rawlinson, request that an investigation be carried out into the serious crimes, being committed by the named actors within clause (3) page 1 of 4; for the following crimes, as I-Am (to be-to exist) here now charge them with, [engaged in or being complicit and allowing], Security fraud, after being warned many times of their crimes, breaching the trust and usurping that which they have no right or consent to, engaged in the act of executor de son tort, to commit security fraud, and forcing upon I :Denis-Peter: a pseudonym, to assume control over I :Denis-Peter: as surety using a persona "Denis P Rawlinson", [exhibit A, continued mail fraud], against my will and consent, to continue to carry out security fraud knowingly with intent to do harm, this they do using coercion, threats and intimidation for their crimes, using a legal fiction name, that all consent has been denied, were a fraudulent name, a derivative of the named estate, DENIS PETER RAWLINSON, ESTATE; ["Denis P Rawlinson" was created without my consent], violating their fiduciary duty, were furthermore all profits derived from the created named derivative DENIS P RAWLINSON, Denis P Rawlinson, "rightfully belonging to the true beneficiary are stolen" ... also a request for further and better particulars, and questions that needed answering, has been ignored, and no full disclosure given, (this is on; record) yet a further attack has continued, which validates the crimes of security fraud, that is continuing against my will, in a sovereign nation that is under an occupying force, and corrupt judiciary, therefore;



(6) Equity will not suffer a wrong to be without a remedy:

As these crimes are and continue to be committed without full disclose, carried out against the people without their freely given consent, particularly in this instance being against I, :Denis-Peter:, the living man and sole beneficiary of the DENIS PETER RAWLINSON, Estate; along with the fact that information regarding full disclosure, is deliberately hidden, for it is not disclosed when requested, and cannot be found, leaving both I, :Denis-Peter: and the average man or woman to the ever growing greed, theft, and control by these actors, hiding behind a named entity, under which the people are treated as slaves, resulting in claims being made against them, using threats and intimidation, being nothing less than rape and plundering to strip living men and women of their personal private wealth, property and assets, to enslave them as surety, and claimed property; by a suppose government agency and corporation that are suppose to serve and protect, not rape and suppress ... and grow fat on security fraud, therefore;

(7) I, :Denis-Peter: the living man request:

That these reported crimes be investigated, As-Soon-As-Possible ... not just for I :Denis-Peter: but for all the people being harmed in Australia, of the sovereign Nation of Terra Australia, therefore;

(8) I:Denis-Peter: Ask for and seek justice:

For the hideous crimes of Security fraud, [usurping that which they have no right or consent to] that being profits made against the named derivative Denis P Rawlinson be it upper case or lower case, that rightfully belongs to I, :Denis-Peter: the sole (soul) beneficiary of the DENIS PETER RAWLINSON, Estate; profits that were stolen under false pretences, and furthermore all money claimed against I, :Denis-Peter: the living man, "by being claimed as surety for that created named derivative Denis P Rawlinson" that was used to hide the crime of those profits, and further create a double dip, having the living man also pay, being a breach of trust and security fraud, "and factually:, there is nothing worse than, theft by deceit and trickery using coercion, threats and intimidation with evil intent, all done by the withholding of full disclosure; and assuming consent, then breaching the trust, with a created derivative name and openly being in violation of the fiduciary duty of all public officials, ignoring the will and instructions of the true beneficiary be they a living man or woman; thereby making any claims the fraudsters assume against the living man or woman, null and void, and open for "cure and remedy", therefore;

(9) Cure and remedy;

As this claimed crime of Security fraud, was knowingly and intentionally done, as facts can be shown "and to this day remain unrebutted under oath", I here now seek cure and remedy, under equity law; that being, the lawful right of any living man or woman, to right a wrong and seek justice for crimes of harm, therefore it is rightfully and lawfully required that "all withheld profits belonging to the true beneficiary of the DENIS PETER RAWLINSON, Estate; gained against the "named derivative Denis P Rawlinson be it in upper case or lower case", created without my consent, being profits that were stolen under false pretences, including all money claimed against I,
