Crimes being Committed, knowingly with intent to do harm; to I, :Denis-Peter: "now a proven fact", by the latest attack, ignoring the requests and will of I :Denis-Peter: who is being harmed knowingly with intent, by the following named Actors, Rod Duke,(Chief Executive Officer); Peter Scott, (Executive General Manager, Finance); Phil Garling, (Chairman); Mark Algie, (Director); Helen Stanton, (Director);Vaughan Busby, (Director); Teresa Dyson, (Director); - and the named entity they hide behind, ERGON ENERGY QUEENSLAND PTY LTD ABN 121 177 802, Going under the Name ERGON ENERGY [exhibit A], of which ERGON Energy Network is a subsidiary company of Energy Queensland Limited a Government owned corporation owned by the Government of Queensland; [exhibit B], therefore;





(4) Equity aids the vigilant, and not those who slumber on their rights;

The Claim:

I :Denis-Peter: here and now in this now time accuse those named within, clause (3) page 1 of 4; in both their acting roles as well as in their private capacity; also including the named entity, ERGON ENERGY QUEENSLAND PTY LTD ABN 121 177 802, of violating the Securities Exchange Act 1933 and 1934 – NYSE; of which the, QUEENSLAND TREASURY CORP CIK#: 0000852555, Come under, being a section of the QUEENSLAND government which own ERGON ENERGY QUEENSLAND PTY LTD ABN 121 177 802, and of which the occupiers of the offices of Treasurer and Minister for Investment “Cameron Dick MP” and the Minister for Energy, Renewable and Hydrogen also being the Minister for Public Works and Procurement “Mick de Brenni MP”, are share holder in the Entity, ERGON ENERGY QUEENSLAND PTY LTD ABN 121 177 802, unlawfully claiming the people of Queensland, as assets, (being nothing more than owned things), being a grave insult to the- people of Queensland who are the true, owners of all assets within Queensland, which includes parliament, “being the people”, furthermore, which brings into question a possible conflict of interest? And therefore;

(5) Equity will not allow a statute to be used as a cloak for fraud;

The wrongdoing that also includes trespass:

I: Denis-Peter: of the house of Rawlinson & Dick, request that an investigation be carried out into the serious crimes, being committed by the named actors within clause (3) page 1 of 4; and the two named share holders, the Treasurer “Cameron Dick MP” and the Minister for Energy, “Mick de Brenni MP”, for the following crimes, [engaged in and for allowing], Security fraud, [usurping that which they have no right or consent to] misprision in office, Misleading, Deceptive and Unconscionable Conduct in office, engaged in the act of executor de son tort, and Continuing to treat I :Denis-Peter: as a pseudonym, even after consent was revoked and denied, yet are continuing to fraudulently claim I :Denis-Peter: as surety using a persona D RAWLINSON, [exhibit C], against my will and consent, committing fraud knowingly with intent to do harm, using coercion and engaged in the threat and intimidation of disconnection of an essential power supply, being an unalienable right, that belongs to the people, violating the laws of the Commonwealth of Australia Constitution Act 1901 as proclaimed and gazetted, all done to force I, :Denis-Peter: the living man, [exhibit D], to pay a demand against a legal fiction name, that all consent has been denied, were a fraudulent name [for a fraudulent trust D RAWLINSON was created without my consent] created against, I, :Denis-Peter: violating the fiduciary duty of all public officials, whose duty is to serve and protect the people, not rape and plunder ... along with the fact that the name being used has absolutely no correlation with the real name of I, :Denis-Peter: or the name supplied, and the name being demanded it be replaced with, also; a recorded delivery of a request for further and better particulars, and questions that needed answering, has been ignored, and no full disclosure given, yet a further attack undertaken, which validates the crimes, furthermore, therefore;

Cure and remedy;

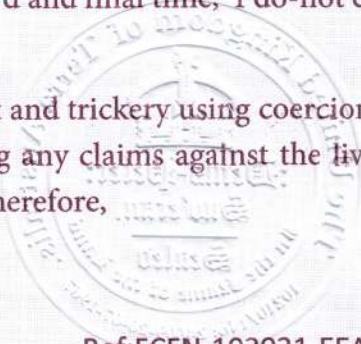
