**Notice of Harm & Injury**

Attention: John Pearce

1. You have had ample opportunity to provide me with your valid Authority to Act concerning City of Prospect's jurisdiction in regard to
  - (i) taking private photos of me on August 10 2023 and
  - (ii) retaining those images in Council records to misappropriate for profit in regard to expiation 515963
  
2. Lawful Due Process: A claimant must prove their claim.
  - (i) You have provided no evidence of any valid **Authority to Act** in this matter.
  - (ii) In fact, you have violated your own Statutory and Legislative Acts.
  - (iii) You have broken your own laws.

7—Tracking devices

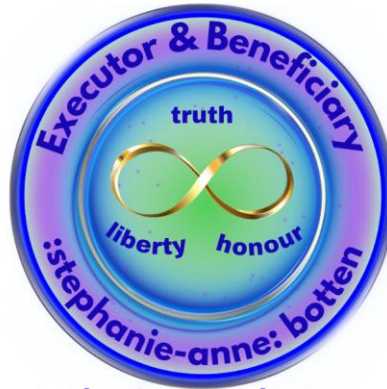
(1) Subject to this section, a person must not knowingly install, use or maintain a tracking device to determine the geographical location of—

- (a) a person without the express or implied consent of that person; or
- (b) a vehicle or thing without the express or implied consent of the owner, or a person in lawful possession or lawful control, of that vehicle or thing.

Maximum penalty:

- (a) in the case of a body corporate—\$75 000;
- (b) in the case of a natural person—\$15 000 or imprisonment for 3 years. The Maximum penalty in the case of a body corporate—\$75 000

3. **Maxim of Law:** Consent makes the law (consensus facit legem) and without that consent there is no law.  
You have No Jurisdiction in this matter.
4. You were given 7 days to respond to my first Notice forwarded to you on 19 February 2024. You have failed to respond.
  - (i) You are not privileged to refuse to communicate.  
**Maxims of Law:**  
He who does not deny, admits  
**Rule of Law**, All are equal before the Law  
All are accountable for their actions  
Corporate immunity is No Defense in Law. It is a legal fiction.
5. The ultimate measure of a Man's worth is defined by his actions.
  - (i) Chris White and Issuing Officer id: 600 have failed to provide any validity for their actions.
  - (ii) They are now in default & have been publicly listed for ALL to see that they never had a **valid Authority to Act**.
  - (iii) As a third party interloper you will also be held 100% personally and financially accountable if you do not respond & uphold Law.
6. If you do not respond by removing my private photos from your records, and cease and desist in their misappropriation for what is apparently a body corporate Private Operating System of Commerce (POSOC) which you appear to be deluding yourself is actually Law, then you will be deemed complicit in racketeering, extortion, fraud, slavery & treason.

8. I am the Executor and Beneficiary of my Express Trust

(i) To overrule the Executor is to deem the Executor a slave.

**Criminal Code 270:** 25 years jail

(ii) To fail to acknowledge Superior Jurisdiction when announced, that being Executor and Beneficiary, the Creditor, or the living man or woman, or any other term used to describe the same, you will be deemed incompetent and removed from your position.

**Grand Jury 26 Order #7 29 September 2023 -**

**Fees for Public Servant misconduct:**

*7.7. Thus a fee schedule to the value of \$66 000 may be applied to any Public Servant who fails to address the Executor in the correct capacity.*

(iii) Not only will I be charging you **\$66,000** if you continue with this belligerent, delusional behaviour over an absurdity – a “frivolous and vexatious matter”, to use your private, legal corporate jargon, but I will also be applying penalties, in accordance with your own legislation - **\$15000** to you personally and **\$75000** to the City of Prospect.
