#### NOTICE OF DEFAULT

On 09 February 2024 you encroached on my correspondence with CEO, Chris White and wrote ***“I reiterate Council's position that evidence will not be deleted from Council records and expiation”***.

On the 19 February 2024, I responded by stating I did not accept these claims. Moreover, I deemed these claims both a Breach of Office and a Breach of Trust.
