of my person are used for commercial advantage and is inclusive of your frivolous, yet very confident claim that your company would prevail in a private corporate “court of competent jurisdiction”.

5. It is in my experience that your confidence and superior sense of jurisdiction are based on your past successes simply because your commercial “court of competent jurisdiction” does not appear to make rulings on Maxims of Law.
6. Your unmitigated presumption of power and success reminds me of George Orwell’s novel – *All animals are equal, but some animals are more equal than others* – The ultimate example of the pigs’ systematic abuse of logic and language to control their underlings.
7. Maxims of Law are inherent rights of every living breathing sentient individual.

The following maxims unequivocally relate to this matter:

1. All are equal before the law
2. All are accountable for their actions.
3. Corporate immunity is no defense in law

*All are equal before the law:*

- a. Employees of the City of Prospect, paid by the public purse, cannot follow a legal system that has been written with me, a private competent individual as the debtor when I am the creditor.

Corporate immunity is no defense in law:

- d. Corporate immunity is a legal fiction. It is not law.
  - e. Corporate immunity is a part of a private legal system that that has been written designating me, the living breathing individual as the debtor when I am the creditor.
8. A legal fiction corporation, in this case The City of Prospect, may not assume to have jurisdiction over the living breathing individual without first providing said individual with the alleged authority to do so.
9. Failure to provide that alleged authority is an act of slavery.

A valid verification of Authority to Act would include that you are employed as a public servant, by a “We The People” government and not a privately owned corporation, which would be a de-facto government and the Authority to Act based on Maxims of Law, and an Oath of Office to serve the People would need to be sighted and recorded.

11. My observation in reading your letter is that your authority is not based on a “We The People” government but rather a privately owned corporation, which is a de-facto government, hence your frivolous and vexatious claim, that my claim has no *“realistic prospect of success if commenced against Council in a Court of competent jurisdiction”*.
12. I instruct you to strike those images of me and my granddaughter from your records and immediately cease and desist with any alleged legal action to gain commercial advantage through them.
13. Having so concluded, I write from the office of my Executor and Beneficiary Express Trust: In accordance with Maxims of Law, I have made a decision to dismiss any alleged authority by the City of Prospect to Act using my images for profit, not only as no valid verification of that Authority has been produced but also on the basis that I find your claim *“no further correspondence will be forthcoming from my staff or I in relation to this matter”* to be belligerent, vexatious and misconceived in nature.
14. Any further use of my images for commercial gain will be deemed an Act of Slavery and full personal liability and accountability will be incurred by:
  - 1) City of Prospect \$75,000
  - 2) Issuing Officer \$15,000 or 3 years imprisonment
  - 3) Chris White CEO \$4000 - based on Order 16.1 27TH Terra Australis Grand Jury, 11.11 am AWST 29.10.2023 we are charging you \$500 per hour for the consumption of my time and energy researching this matter, seeking lawful counsel and for writing correspondence.
