This is the **Voice** and Council of First Nation, and all matters must be approved by this Council to proceed.

Hi Yanina,

1. Thank you for your reply 28.7.2023.
2. Please be advised **Crown: We The People of Superior Jurisdiction** are always a party to all matters pertaining to **Crimes Against Humanity** and failure of **Lawful Due Process**.
3. Which we recognise to be the case here, as no paperwork is forthcoming to substantiate how and why Kaiden Smith continues to be incarcerated despite the original claimant withdrawing her claim 7 times.
4. It is slavery to hold an individual incarcerated without **Lawful Due Process**.
5. Criminal Code 270 Slavery 25 years jail.
6. And yet repeatedly, as we see in all the broken court system, the claimant is not made to prove their claim.
7. Please provide to Aaron, **urgently and immediately**, any paperwork responsible for this incarceration and the names of the individuals who are actioning that.
8. A Department cannot do such a thing as it is a legal fiction.
9. There is now; no such thing as a private corporation: inferior jurisdiction, enacting its private world of commerce upon the good lives of Humanity, for profit.
10. That era has finished. We see clearly through it, and it is legal, **not** Lawful.
11. Kaiden is in bereavement circumstances for his Mother. Bronwyn is a First Nation Elder.
12. These measures at such a time are taken very seriously.
