24. All matters are **offers**.
25. **Maxim of Law:** Free Will and Informed Consent are essential for everything.
26. Thank you for your **offer** to contract.
27. All contracts are an offer and acceptance.
28. The presumptions of the Court via the use of a 'registration' process are Null and Void.
  - 28.1. No such presumptions may exist without full transparency and a meeting of the minds. This has never happened.
  - 28.2. No one of sound mind would trade their inherent rights for benefits.
  - 28.3. This is a system of Guardianship. Also known as slavery.
  - 28.4. The Courts are of commerce, not Law.
  - 28.5. And that is the **essential element** for all parties to be aware of.
29. Such **offer** is known to be one of 'accept or reject' and is not a one sided business matter in favour of the Judiciary, as is consistently witnessed, with all manner of AI presentments to follow, including:
  - 29.1. increasing alleged debt,
  - 29.2. threats of incarceration
  - 29.3. threats of revocation of tools in commerce: eg drivers license, assets, etc.
  - 29.4. This conduct is strictly forbidden by the Public Servant sector.
30. It is apparent, by numerous extensive Audit and Investigation processes, that the current Judiciary is struggling with:
  - 30.1. taking the position of Trustee when the Executor and Beneficiary makes an appearance at the Court for any matters.
  - 30.2. It is struggling with following Lawful Due Process.

30.3. It is struggling to follow even its own processes it has created for itself.

30.4. Whilst respect is given to this private enterprise which may use the resources of

***Crown: We The People of Superior Jurisdiction:*** such as our jails, to

incarcerate true offenders, who have caused genuine Harm and Injury, it is clear there is a gross over reach of this system; to attempt to profit from any and all trivial matters of which it has no business interfering in.

31. Thus the following fees and remedy, as passed by Terra Australis Grand Jury, thereby being the highest jurisdiction upon these lands, are available to Humanity, to hold accountability to Judiciary, and others, in such circumstances as:

31.1. Failure of Lawful Due Process: All Are Equal Before The Law.

31.1.1. The claimant must prove their claim.

31.1.2. The claimant must be present in the courtroom.

31.1.3. The defendant must be heard.

31.1.4. Only then can remedy be applied.

31.1.5. Public servants paid on the Public Purse: eg: Police, may not take the role of Prosecutor, whereby Humanity then picks up the expense of such process. This is an increasing problem.

31.1.6. If the claimant is not in the Court, there is no case.

31.2. engaging in frivolous and vexatious pursuit of innocent matters.

31.3. attempting to exert jurisdiction over affairs where no jurisdiction exists.

31.3.1. Eg: alleging to have jurisdiction over First Nation individuals who have never ceded their Sovereignty and ancient tribal Lore to a foreign legal system.

31.14.allege to be able to impose a privately owned Statutory and Legislative framework upon Humanity and call it Law. And believe they are then not answerable to Law.

31.15.uses the red Devils chair to shackle the Executor to the Baal/bail papers.

31.15.1.Red chairs should be removed from all courts and any chairs that serve the same function.

31.16.allege signing a bail paper is the only way someone can leave the Court. This is misinformation since everything is an **offer and acceptance**. An offer to be attached to bail must be presented.

31.17.The illusion of this system is over.

32. Permission can be granted by the Executor and Beneficiary for sufficient remuneration from the Master Trust for all matters on the table. The Executor may assign a payment for services rendered by the Judiciary.

32.1. The Judiciary may submit a genuine cost for the running of the POSOC in finalising matters, as per current standards of assigning costs. The Executor will approve such costs and will be remunerated by set-off using the Creditor ledger.

33. It is appreciated that this is a new language and process for the Judiciary. However, it is simple in context and should not be ignored.

**38. Terra Australis Grand Jury 25: 31.8.2023 Order # 7**

**38.1. In addition to Terra Australis Grand Jury 12. Order # 3 12 August, 2022**

*Re: Judges and Magistrates, being of inferior jurisdiction: due to being part of the Poor Laws 1535 and their ongoing development to this modern day, and being part of a system that was created without the free will and informed consent of*

**Crown: We The People of Superior Jurisdiction:** *Those who fail to acknowledge Superior Jurisdiction when announced, that being Divine Special Appearance, or Executor and Beneficiary, or the living man or woman, or any other term used to describe the same, will be deemed incompetent and **removed** from their position.*

**38.2. GJ25: Order #7 , at the choice of the Executor, may incur a fee of**

**\$333 000 AUD in equivalent hard assets, eg: Gold or Silver.**

*for perverting justice for a first offence. To overrule the Executor is to deem the Executor a slave. Criminal Code 270, Slavery, 25 years jail.*

### 39. Additional Orders by Terra Australis Grand Jury's

#### 39.1. **Grand Jury 12. Order #5**      **12.8.22**

All residential electric accounts are now paid by the Master Trust.

#### 39.2. **Grand Jury 13. Order #2**      **10.9.22**

In this Order, we collectively change the jurisdiction of the Birth Certificate from being privately owned by the private member association that calls itself the global government, and is now the property of the People, as an administration tool for commerce, facilitating access to inherent right to resources.

#### 39.3. **Grand Jury 13. Order #6**      **10.9.22**

Further, no corporation may respond to communications, with just a department cited. A name must be attached to the response.

#### 39.4. **Grand Jury 13. Order #7**      **10.9.22**

The doctrine of parens patriae is deemed Null and Void and Judges and Magistrates are strictly forbidden from using it.

#### 39.5. **Grand Jury 14. Order #5**      **10.10.22**

Pertaining to Order 3 and 4: Accurate accounting must be made transparent at quarterly increments, and All essential services need to be addressing their accounting and moving the debtor back into the Creditor position, and moving themselves into the debtor position and returning receipts of correct book keeping

### 39.6. Grand Jury 14. Order #6 10.10.22

No essential service may disconnect any individual from that service, this includes telecommunications, without incurring a **\$2000** per day fine and a public listing. Essential services may not have, as part of their AI Communications, threat to Disconnect.

### 39.7. Grand Jury 14. Order #7 10.10.22

Every individual needs to craft their Letterhead of Executor and Beneficiary, as per the example provided and conduct affairs in such a manner as to accept the Bill received and expect the public servant sector to adjust the accounting, and send a receipt for the correct accounting.

### 39.10. Grand Jury 16. Order #5 8.12.22

At any time We The People are free to declare the Guardianship over, and to put them in the position of Trustee and we take the position of Executor and Beneficiary and are free to communicate via the Executor and Beneficiary letterhead, and issue instructions to disperse resources. And just as they persist in ignoring the Creditor to maintain their position of war, we persist in holding accountability to bring about Peace and Prosperity for all.

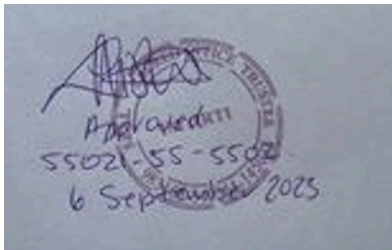
