23. The Australian Government is essentially the vaccination industry, in disguise.

24. That industry is Operation Paperclip, that scattered the scientists and their experiments after WWII ended September 1945 and the United Nations began October 1945.

25. This is the same power and control mechanism . In plain light to see.

26. The vaccination industry runs the Social Services sector, have a multi layered voice in all payments within this system that we own and pay for.

27. And even has the audacity to have in it's Terms and Conditions that it can disconnect anyone at any time. Thus, this could not possibly be a **Crown: We The People Of Superior Jurisdiction** arm of government. As no such condition could exist in a People owned service sector such as this.

28. Thus this system is clearly identified as one of slavery. Criminal Code 270, 25 years jail.

29. In this modern day; this is the unelected *Klaus Rothschilds Schwab* version of reality.

30. Financed by the privately owned Rothchilds Banking system 1913, Federal Reserve Bank.

31. This entity is now foreclosed on, globally, due to it's violation of **Maxims of Law: Free Will and Informed Consent.**

32. Humanity cannot be in debt to a privately owned currency. That is classified as slavery. Criminal Code 270: slavery 25 years jail.

32.1.The USD was privately owned: United States Dollar (USD) and has been replaced by global powers; with the United States Treasury Note. (USTN).

32.2.An asset backed currency system, under the wing of the Treasury.

33. We are emerging from a **class based** system, as evidenced at 38.1.

33.1.Whereby the Administration takes the position of the Private, and manages your Private for you, via the system of **Guardianship.**

45. Humanity is not chattel. Nor slave. Humanity is the **Creditor.**
46. That time of Humanity as the debtor is finished now.
47. Papal Bull: Doctrine of Discovery: May 4 1493 - March 30 2023. Created by Pope Alexander the VI. 530 years of carnage.
48. This document allegedly facilitated the rape, torture, murder, pillage and plunder of First Nations around the planet, and theft of land for colonisation.
49. This is now recognised as **Crimes Against Humanity**, and was rescinded by the Catholic Church March 30 2023, as an embarrassment of behaviours against the wellbeing of Humanity.
50. **Maxim of Law: All are accountable for their actions.**
51. This entity: the 'Australian Government'; does operate under **treason, fraud and slavery**, by misrepresenting itself in the Community and imposing privately owned rules upon Humanity, that have **no force in Law.**
52. This is a private Legal system. It is not a Lawful system.
53. It positions Humanity to be a **debtor** slave.

55. A persistent Judiciary to attempt to ignore the Executor and Beneficiary is of unsound mind.
