URGENT AND IMMEDIATE MATTERS.

Kidnap and Hostage of children by Public Servants paid on the Public purse; by Failure of Lawful Due Process.

1. This communication comes in Peace.
2. **RE: Failure of Lawful Due Process, resulting in Kidnap and Hostage.**
3. The claimant must prove their claim **before** enacting penalty, or remedy.
4. This has not happened.
5. **Crown: We The People of Superior Jurisdiction**; recognise that within the private legal system, but not lawful system, of the Private Members Association (PMA) that calls itself the Australian Government and is upon these lands without invitation, without treaty and without

blessings; has a distinct disregard and disrespect for **Law: Rule of Law: All Are Equal Before The Law.**

6. And does process Humanity as the Debtor, when Humanity is the Creditor.
7. And does process Humanity as chattel slave.
8. And does process Humanity as being under Guardianship, without free will and informed consent.
9. Humanity is **Crown: We The People of Superior Jurisdiction**, and the public servants are the public servants of inferior jurisdiction.
10. The illusion of authority is 100% Null and Void.
11. Humanity is not under Guardianship.
12. Rule of Law: All Are Equal Before The Law is hereby restored.
13. The Guardians are moved to the position of the Trustee.
14. Incompetent Trustees are removed from Office.

15. The Hume/Rodd children have been kidnapped almost 300 days, and the claimant has failed to win their pursuit of a 2 year Order, before the Children's Court -
 - 15.1. A Court of Inferior Jurisdiction
 - 15.2. A Court of the fictional Board of the Guardians
 - 15.3.** Before Magistrate Horrigan who is **applauded** as the first Board of the Guardian who has performed as a competent Trustee and has overseen the wellbeing of the children, and not facilitated that Child Trafficking perpetrated by the Department of Child Protection, under the direction of Phoebe, and others.

16. Judge Quail is one of 11 defendants, found guilty on 5 counts of Crimes Against Humanity.

17. Before a Common Law Court of Superior Jurisdiction 30 July 2023. Before a jury of 13.

18. Court verdict has been provided previously.

21. Hume & Rodd, 3 children:

22. **Terrence 9**, taken by Public Servants by Failure of Lawful Due Process. Therefore kidnap and hostage. 5 December 2022. 282 days.

23. **Lytrell 3**: taken by Public Servants by Failure of Lawful Due Process. Therefore kidnap and hostage. 5 December 2022. 282 days.

24. **Olivia - 7.5 months**. taken by Public Servants by Failure of Lawful Due Process. Therefore kidnap and hostage. 11.3.2023. 185 days.

25. And by association and within the same family:

26. Nephew to Terrence Rodd Snr: **Newborn Baby Wallace**. Taken without Lawful Due Process from Bunbury Hospital. Therefore kidnap and hostage. 7.8.2023. 185 days.

27. And cousins: **Kingsley 11**. Taken without Lawful Due Process. 4.9 2023.

Therefore kidnap and hostage. By Phoebe, Busselton DCP, with assistance of Busselton Police. No paperwork in progress to support such actions.

28. and **O'Shae 4**. Taken without Lawful Due Process 4.9 2023.

29. Therefore kidnap. By Phoebe, Busselton DCP with assistance of Busselton Police.

No paperwork, of Lawful standing, is in progress to support such actions.

30. And **Axel 15** -repeatedly incarcerated in Banksia Prison, signing documents without Counsel present. 4.9 2023.

31. Orders presented to Magistrate Horrigan for the Trial did include:

32. Therefore: you will either Order:

32.1. the immediate return of the children as per multiple previous Orders of Superior Jurisdiction including from the **First Nation Sovereign Council. (FNSC)**. All of which have been provided to you and the office of Melinda Castle, who is also one of the 11 defendants found guilty of 5 charges of Crimes Against Humanity and sentenced to a 75 year jail term and is scheduled for House Arrest.

As at 11.9.2023, Melinda Castle is under House Arrest.

32.2. You will Order the house that Vicky Penny lives in at 23 Honeyeater, Geographe is brought up to habitable standards. That house being an asset of **Crown: We The People of Superior Jurisdiction**, and maintained at standards of disrepair by Department of Communities - Housing.

Who is in charge of this, and where is the matter at?

32.3. And Order that Department of Housing move forward immediately the request for alternative Housing for Vicky Penny, Cheyenne Hume and Terrence Rodd, and children,

that is away from Busselton where they report they are perpetually harassed by Busselton Police.

Who is in charge of this, and where is the matter at?

32.4. And Order the immediate return of the 4 other children of this family Wallace, Kingsley, O'Shae, and Axel.

Who is in charge of this, and where is the matter at?

32.5. And recognise that this administration that you Magistrate Horrigan are a part of, is here,

32.5.1. via the use of the Birth Certificate as a source of funding.

32.5.2. That the First Nation 'family' as a collective have never ceded their Sovereignty,

32.5.3. have never come under the jurisdiction of this administration.

33. It is noted that, by witness account of Averil Williams, Independent Children's Lawyer: Ms Johnston, did refer to Terrence, whilst in the trial, as a 'monkey'.

33.1. In a meeting Saturday 16.9.2023 the Elders of the First Nation Sovereign Council (FNSC) did dismiss Ms Johnston from her duties as Independent Children's Lawyer, deeming gross incompetence.

33.2. The FNSC do observe that their work has been ignored, that is, to return the children. All matters are being watched carefully in regard to this case.

33.3. Perpetrators of this slavery may come before a Tribal Court of Lore for their trespass upon First Nation Children.

34. It is acknowledged by word of the Grandmothers, Vicky and Averil, and by Terrence, that on the first day after the Trial in which Magistrate Horrigan did facilitate a 6 week window to assist the family to have remedy applied regarding housing and part time work, that Florence has threatened Terrence with a Restraining Order, to further divide the family. Hence it is clear, the DCP is not poised to assist, but is positioned to create further divide and disruption.

This is accountability to Lawful Due Process.

35. Florence: Vicky has deemed to not be the Legal Guardian the children. Vicky is the Lawful Guardian of all the children. Vicky is the Grandmother of the children. First Nation have never ceded Sovereignty.

All children must be returned immediately.

36. **These matters must be addressed or inevitably:** be deemed as complicit in facilitating kidnap and hostage and attract the same outcomes as Judge Quail who had no problem facilitating a failure of Lawful Due Process and is therefore incompetent at the bench, a danger to community and is now publicly listed for dismissal and House Arrest.


