13. You may have matters with the parties who sold you a property that had failed **Lawful Due Process**, and thus became available for sale.

17. Should **Crown: We The People of Superior Jurisdiction** not hear from you, you have 28 days to vacate the property: 11.10.2023, to 1.11.2023. 11am AWST.
18. For your reference: Please see the attachment presented to the Grand Jury, by Rod Culleton; of the broken paper trail of the movement of the property through 3rd parties, who did not have a valid contract with the then Title holder.
19. Please also hear the recording of the Corporate Sheriff stating the Possession Order was not valid. <https://screenpal.com/watch/c06e1RV5Zb8>
20. Should you wish to Notice a rebuttal, please do so, and include your own lineage of documents in regard to this matter, to be cross referenced as witnessed by the Jury.

23. Your documents will be reviewed by 18.10.2023 11am AWST, for your feedback.

25. This matter is no longer available to be heard in a lower jurisdiction court as it does not recognise the Maxims of Law and thus did facilitate this transaction, of a **failure of Lawful Due Process** to occur.

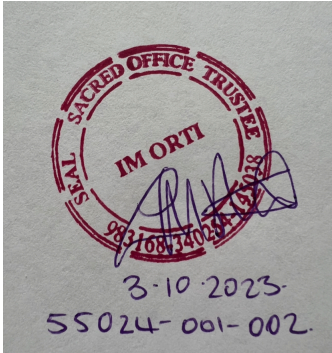
