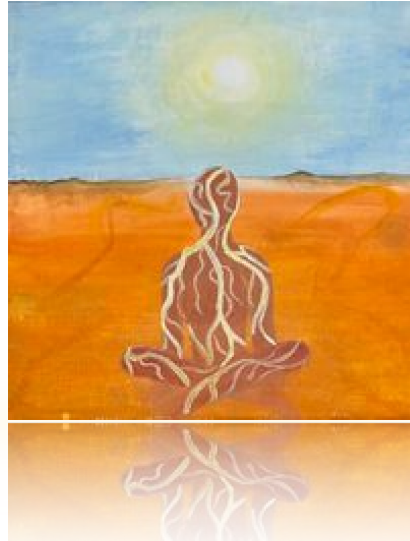

15. Disenfranchise the family, to achieve ongoing land theft
16. Usually by putting the father in jail
17. Steals the children
18. Puts the parents onto job seeker status whilst the children are stolen and living in 2 separate foster homes
19. Foster carers paid to raise someone else's children.
 - 19.1. New Rules for Foster Families
20. The Department of Housing maintain a dialogue that there is no housing available.
 - 20.1. Latest update from housing is that it is a 3 year wait.
 - 20.2. Magistrate Horrigan has not facilitated remedy within her own system and has been unable to action outcomes in favour of inherent rights and facilitating the children to return home by doing fair and equitable distribution of resources, by ensuring this young family had the resources they needed.
21. This young First Nation family left homeless on their own land.

23. The entire system is a legislative framework laid over the top of the land mass.
24. And can be extinguished from power, as it is based on treason, fraud and slavery.
25. Flies a FIRST NATION flag outside the Childrens Court and on the 6th floor of the DCP, despite having ZERO jurisdiction in the affairs of FIRST NATION.
26. Government Departments refer to Law as a 'belief'.
27. 'You are free to believe that. We believe something else.'
28. No understanding is evident of **LAW: MAXIM OF LAW, RULE OF LAW: ALL ARE EQUAL BEFORE THE LAW**, is a timeless measurement and a benchmark of safety and security, values and ethics.
29. **Failure of Lawful Due Process** is a violation of inherent rights, and is measured by these timeless standards.
30. The **failure of LAWFUL DUE PROCESS** that facilitated the theft of the 3 Hume-Rodd children, via the 424 document, has been left unaccountable for by Perth Children's Court - A Court of Human Trafficking.

URGENT AND IMMEDIATE MATTERS.

1. AN URGENT AND IMMEDIATE update is required by Magistrate Horrigan
2. from the Perth Children's Court,
3. officially closed by Superior Jurisdiction 21.8.2023.
4. And noting President Judge Quayle was one of 11 defendants found guilty of 5 Crimes Against Humanity, specifically for this case, albeit this case being a template for thousands of others.
5. Judge Quayle continues to issue instructions to Ventia Security.
6. Ventia Security have been served Notice of TERRA AUSTRALIS GRAND JURY Orders regarding facilitating the Court to continue to run a child trafficking racket facilitated by a failure of Lawful Due Process.
7. In recent times Ventia Security have engaged in
 - 7.1. Positioning large guards at the stairs to prevent entry even onto the stairs at the Perth Children's Court
 - 7.2. Have laid hands on Common Law Sheriffs, at Fremantle Court 20.11.2023
 - 7.3. Ventia Security refused to give their names. Believing they had every right to not show them.
 - 7.4. No such privilege exists for these Public Servants.
 - 7.5. Nicky, last name currently unknown, did not know that she was a Public Servant, paid on the public purse via a Government contract.

8. Notice that Terrence Rodd has spent two separate jail terms this year.
 - 8.1. Both were for matters where there was no claimant, in the Court, and no evidence.
 - 8.2. Both matters were eventually thrown out.
 - 8.3. Notice was repeatedly given to Magistrate Andretich. Which she repeatedly ignored and is found guilty of Crimes Against Humanity.
 - 8.4. Andretich was dismissed by the **Sovereign Peoples Assembly Western Australia** hearing, July 30 2023, in which 11 defendants were found guilty on 5 charges of Crimes Against Humanity. Specifically related to this case.
 - 8.5. Clearly these standards fail any recognition of Lawful Due Process.
 - 8.6. Compensation will be assigned for these wrongful incarcerations.
 - 8.6.1. These incarcerations are recognised as organised attempts to persecute a young First Nation family by disempowering the father figure and taking the children in case. **This is an old and well oiled industry.**
 - 8.7. Further.... In addition to prior Orders. All sent through the Court and the DCP.

9.1. Order #10: The Hume / Rodd children. First Nation.

9.2. nGoodthala to speak of his memories of being a child and hiding under the bed when the DCP cars arrived. Living a life of terror.

9.3. Now in foster care approximately 330 days by failure of **Lawful Due Process**, in the now defunct Children Courts, which facilitates the '**stolen generation**' via the corrupt practices of the Department of Child Protection and fails provision of housing via the Department of Housing.

9.4. At the hearing for **November 3 2023**, and further to multiple Orders already passed by the **Terra Australis Grand Jury of Superior Jurisdiction** and by the **Sovereign Peoples Assembly Western Australia**; and by **First Nation Sovereign Council**; and given Notice of, all of which have been ignored by Belligerent Occupation;

9.4.1. Magistrate Horrigan will award return of the 3 children ages, 9, 4, and 8 months to the rightful parents and greater clan.

9.5. And will ensure Department of Housing provides an appropriate house **immediately**. Such Corporation being a guest on these lands

9.6. And will ensure parenting payments are reinstated for this young family and job seeker status is removed.

9.7. What say you jurors?

9.8. Unanimous yes.
