1. Darrell Foote is a **Human Experiment**. Without a doubt.
2. To read the accompanying documents of the ingredients he is being administered is to witness a toxic concoction that could only lead to a string of horrific health outcomes, including death, and as per document 7, attached, the only:
 - 2.1. *'outcome of interest is death: by **suicide** or natural causes'*.
3. Document 1: *The maximum dose should not be more than 400mg and the total number of injections should not be more than 4 per course of treatment.*
