12. We also recognise that some public servants assert powers and privileges to themselves that do not exist, thus taking on the role of ruler.

7. Unanimous Yes

21. **ORDER #7.** We define terms between the matters of customary lore, law, and a 'private legal fiction'. In this context, lore and law may be viewed as the same, but simply from different dialects. And does call upon **the inherent divine principles of creation**: we are all created equal.
22. Customary lore advances these fundamentals by offering forth the subtleties of ritual and tradition of a given tribe, that being a tight community within a given land space.

at the early stages of seeing the longer term effects of the depopulation program.

47. In 1986, Ronald Reagan signed the National Childhood Vaccine Injury Act (NCVIA) into the private legal fiction, commonly referred to as Law. And this law created the VICP. The Vaccine Injury Compensation Program (VICP) protects the pharmaceutical company from liability related to vaccines. If someone suffers from a vaccine injury, they can't bring a lawsuit against the manufacturer. Instead, they must make a claim to the government, and then, they may receive compensation through this program. However, **this is not law** as it moves accountability, thus facilitating this model to perpetuate a vaccine injury at a human experimental level. This fails law and is Null and Void.
