6. As part of the Grand Jury, we are mapping the new Sun cycle that began last Grand Jury. As Sun defines our sense of identity as individuals and thus as a collective, it is important that we capitalise on the energy fields at a given time and craft the unspent potentials. Thus we become the Conscious Architects of our future. As we are emerging out of slavery, there is a great unspent potential to define what we are capable of as a humanity.

Grand Jury 8 : was Aries- the I AM. The relationships axis. Which was Sun in Aries and one of the pivotal elements we anchored in was the defining of jurisdictions, and those jurisdictions that still exists, never having been surrendered. This essentially disempowers the alleged authority of the current system in areas such as Indigenous incarceration.

Grand Jury 9, today. is the Resources Axis, Sun in Taurus - I Have. Moon in Scorpio - I Desire. Thus in this Jury we are going to get a lot clearer on speaking a different language that defines our jurisdiction, because that is our first resource. If we do not know who we are, then we have no hope of putting it to use and utilising essential timeless benchmarks that guide all decision making. 9. Orders:

1. There is a need to acknowledge, that in empowering the above tools via this Grand Jury, that being the wallet size fillable Notice and the use of the Notice of Special Appearance, that those using these tools would conduct themselves only in the highest honour, would not be belligerent in any way, nor enter in conflict in any way, recognising that to enter conflict is to in fact negate one's standing by one's own hand. ie, the King, or the Queen does not argue that he or she is the King or Queen, but merely holds standing.

Part A: Do we grant ourselves permission to at all times feel free to request verification of Authority to Act by all government departments, and if that department cannot define its position, then render the environment free to discontinue eg: a Court assigned Psychologist, who cannot define the jurisdiction, but has the intention of interviewing eg, mother and child, writing a report about mother and child, filing the report on the record, and potentially having Court Orders created as an outcome of that report.

5. Part B: Do we grant ourselves permission: If for example, the government department was Centrelink, and it could not provide proof of jurisdiction, but you require the service it is offering, that you ensure you have put onto the recording, that you are attending this matter in Crown Jurisdiction. A term recognised in their system, as Crown is used interchangeably throughout their Acts. And that you are issuing instructions to the public servants of how to manage your affairs. You can either record the conversation yourself, and or write it up and upload it.

6. For safety reasons; when attending a Court matter, that the Notice of Divine Special Appearance is filed into the Court ahead of any attendance.
