#### 1. Clarifying Terms:

- 1.1. Rule of Law: All Are Equal Before The Law
- 1.2. Crown Jurisdiction
- 1.3. Natural Law
- 1.4. Common Law
- 1.5. And any terms used by individual dialects of First Nation tribes to describe their system of customary Law
- 1.6. Will be acknowledged as Superior Jurisdiction.
- 1.7. And will refer to the free will of 'We The People'.
- 1.8. And be the Superior decision making mechanism within any given People on Terra Australis.
