1. This is the 13th Terra Australis Grand Jury of **'We The People'**. Beginning on the Equinox of 23 September 2021 and on every full moon since.

16. Forever recognised as the true custodians of Mother Earth.

17. ***The Meek Shall Inherit The Earth.*** Matthew 5:5

18. This Court recognises, acknowledges and respects the Original Custodians of this land Terra Australis and recognises all tribal matters and business to be of equal jurisdiction to this Court. That is: humanity is a self governing organism, not an entity to be enslaved and administered in a privately owned legal fiction instrument, such as Unum Sanctum of 1302. An outcome to the Magna Carta - Rule of Law: All Are Equal Before The Law.
19. And onward from there, the Poor Laws of 1535

Order # 1

Order #5
