1. Order #1: Health protocol monopolies are strictly forbidden.

2.1. National Sheriffs can be recruited by a call out for interest.

2.2. Voting by an assembly can be foregone.

2.3. All sheriffs must still be a member of a Common Law Assembly.

3.3. Thus a Lone Sheriff may not go out into the field alone.

3.4. All sheriffs must be committed, ie, attend meetings, in person or via zoom at the least, attend assemblies, attend operations.

3.5. All assemblies with Sheriffs must make a priority, the duty of care to the Sheriffs.

4.1. Sheriffs may investigate cold case crimes that state police refuse to look at.

7. Order #7 Parliament House/s

7.1. **Crown: We The People of Superior Jurisdiction** declare; as all structures and houses of parliament are the property of the People, we hereby instruct the Common Law Sheriffs to remove the corporate entities occupying these premises and Office and return them to Constitutional function under **Rule of Law: All Are Equal Before The Law** and **Lawful Due Process**.
