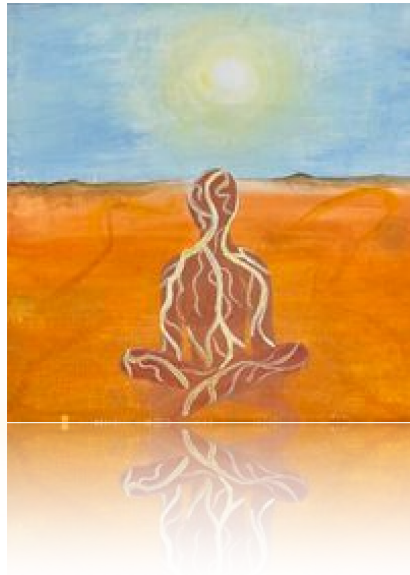

9. **Crown: We The People of Superior Jurisdiction have**, as at 24.1.2024 :
 - 9.1. Convened 30 Terra Australis Grand Jury's
 - 9.2. Having written and passed before a full Jury: 500+ Orders.
 - 9.2.1. Many of which hold accountability to **unacceptable standards** of Statute and Legislation passed by the privately owned Parliament, to manage Humanity as the **'Human Herd', under the Board of the Guardians, and referred to as the 'Public', and the debtor.**

11. Essentially, we are in the process of Humanity restoring its position as the **Creditor**.

27.3. As we are dealing with an inverted system, it is a fraud to allege a Public Servant Government Department could be the Creditor.

27.4. That is an absurdity in Law.

28. Further; in a communication by Joe Bloggs: dated July XX 20XX, it is established that

28.1. The Deed Settlement and Release was signed by all parties 2X.X.20XX.

28.2. The ATO was party to that as it was represented at every 'Creditors' meeting and voted at the final meeting to accept the Deed of Settlement and wind up the company.

30. Further: the following has been established:

30.1. The I.T.R. (Institute of Taxation Research) has now received irrefutable proof (through an exhaustive Freedom of Information Act search), that the Australian Taxation Office was never officially gazetted in 1973 at its formation.

30.2. Legally, therefore, the A.T.O. does not exist!

30.3. A barrister in Sydney presented this information to a Judicial Registrar who was hearing a liquidation proceeding. The Registrar adjourned the case immediately, after appearing "visibly shaken".

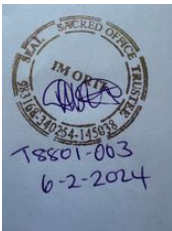
