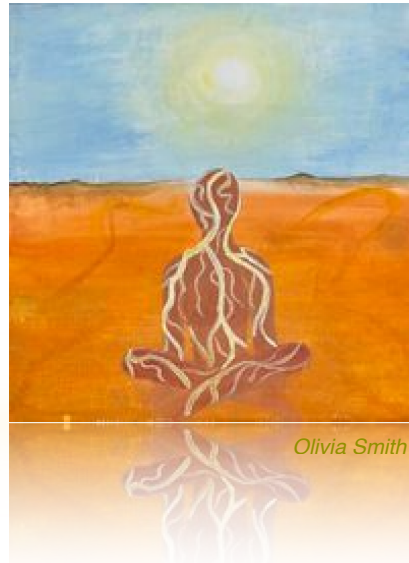

- This communication comes in Peace.
- We have a severe housing crisis. We cannot look to the same minds who have given us the housing crisis, to also give us the remedy.
- As Custodian and Creditor of all resources; via the monetisation of funding from the Birth Certificate; **Crown: We The People of Superior Jurisdiction** offer the following Terms and Conditions to the Australian Government; to continue to do commerce on these Lands without treaty, blessing, invitation nor Bill of Sale.
