Crown Jurisdiction:

Let no public servant dare to allege to have superior jurisdiction.

- 1) This office is advised, that in regard to matters pertaining to Takara Markwell, there has been a 100% failure in **lawful due process** and this matter is under full **INVESTIGATION** for such failings.
- 2) A 12 peer jury will be on standby to process the individuals complicit in this **kidnap and hostage** situation.
- 3) Failure to provide an environment whereby **the claimant must prove it's claim**, that being DCP Noarlunga, before an unbiased adjudicator, is a failure in lawful due process. An absolute basic and essential in law. Or it is tyranny and slavery. Now evidenced to be the latter.
- 4) Further, failure to provide an environment whereby **the defendant may defend herself against such claims**, the defendant being Donna Markwell, standing in Crown jurisdiction, ignored by the Magistrate, is also an **abhorrent failure in lawful due process**, rendering this department to be complicit in slavery of the mother and theft and holding hostage of a 14 year old girl for now 20 days. - 6) All complicit parties are under full investigation. Jobs are absolutely suspended and assets frozen.

7) This department has ZERO jurisdiction in the affairs of Donna and Takara. This has been made clear, and ignored. Thus slavery is evidenced.

8) You are instructed to return Takara immediately.

9) You are cautioned, offending parties are absolutely facing jail sentences for these crimes. The prompt return of Takara will be view favourably.

10) All overseeing governing bodies, within the private legal system of the private BAR Guild, have been contacted, included the Judicial Ombudsman for Magistrate Adair's complicit conduct. This is a standard of gross incompetence. Magistrate Adair is hereby dismissed.
