- c. These two employees are on the ground, ***paid*** to write their names on the Leader Brief stating the Western Australian Government '***Directives***'. These 'directives' are not Law/Lore in any way whatsoever.

- c. Fortescue Metals Group Limited ASX: FMG Share price 17.27AUD 1.12.2021. Total assets 48.05 billion AUD (2020) , a shareholder owned corporation.

 - a. 48. Currently the Australian Board of the Guardians, managing the Futures Fund, with Peter Costello - **public servant** - as CEO, manages \$226B in assets, including all major corporations being 'registered' into the fund. Hence the efficient roll out of the covid19 policies and procedures.
 - a. This is despite being unable to resolve a 'homelessness epidemic' which fuels the homeless industry and the 99 satellite groups that feed off it. Misery and chaos are big business for those who control it.
 - b. Much like the organised 'child kidnap and hostage industry', politely called the 'Department of Child Protection, and foster care industry, assisted by local police'. Also administered via the **'private legal fiction'** Court system, via failure of lawful due process: where children are:
