And thus 100% accountability does rest with each individual and the choices they make in exchange for their pay cheque, and on behalf of the corporation.

- d) All additional names and interactions in this matter will be tabled for public gazette; of liability for any Harm and Injury incurred in pursuing the current claim of trespass by First Nation People, unless the claim of 'landlord' can be substantiated by the claimant.
- 7) At your attendance, you are invited to
  - a) substantiate who or what you are referring to when referencing the 'Crown', and please provide historical lineage of authority. This may include contracts, treaties, proof of financial exchange for land use, etc.
  - b) Please substantiate how the Crown Management Act 2016, as quoted in your communications dated 16 January 2022, claims superior authority of claim of land in this matter.
- 8) Currently, as First Nation individuals are not in the jurisdiction of the Supreme Court of NSW; understandably this matter does not fall within the jurisdiction of the Supreme Court, and will be heard before the Githabul Ngarakbul Traditional, and Rule of Law, Council and Court.
- 9) Thus all costs incurred in pursuit of this matter are the costs of the DPIE, and do include our costs also, unless claim is historically substantiated.
- 10) We welcome you and look forward to observing your documentation.
