3. Equalled via the use of the First Nation terminology of Tjukurpa (pronounced Jook-a-pa)
4. This jurisdiction is henceforth, processed via the ***Githabul Ngarakbul Traditional and Rule of Law Court and Council, in conjunction with TACTIC, the Terra Australis Commonwealth Interim Council.***
