7. The focus of this meeting is to discuss the use of community resources which may not currently be available to community for easy use or access, despite 'right of use' of such resources belonging to community.
 - 7.1. For this discussion, this includes the use of buildings, such as lock up facilities within various Police Stations, such stations being government buildings and such buildings therefore being the resources of We The People.
 - 7.2. Additionally discussion would also explore the use of the WA Police Force: as a public servant sector, in using the uniformed and armed Officers; should community choose to process a court case in the Superior Jurisdiction of Common Law, also known as Rule of Law: All Are Equal Before The Law. Rather than the inferior jurisdiction of Admiral Law: a private commercial system.
 - 7.3. And in the event of assigning an outcome of damages to individual parties, particularly in the wake of the violations of the Nuremberg Code throughout the the recent covid19 pandemic agenda, that the correct facilities are available to follow through with the outcomes.
 - 7.4. The death and injury count, and loss of jobs, and businesses; due to the unfolding of the protocols that did violate critical standards in law, are now very evident, with a long pathway ahead of mapping the repercussions of.

- 7.5. It is essential that We The People, follow up with standards in Law; to ensure these violations are not repeated. Clearly the Nuremberg Code of 1947, an outcome of the WWII, has not been taken seriously by those who should have been working to such standards and the many other time marked documents related to recording, not granting, the inherent rights of We The People.
- 7.6. Informed consent has not been adhered to and the repercussions are very serious.
- 7.7. Additional buildings may also be identified for use in other matters such as health facilities, and facility to ease the trauma of homelessness: a burgeoning industry in the wake of ever increasing interest rates by the private Reserve Bank of Australia, which is undergoing it's own transition during these great times of change.
8. Thus it is proposed, a meeting be held, at a public office of your choosing, that does offer sufficient size table and space for such a meeting to be held. In attendance of ourselves, please expect no less than 6, but no more than 10. This detail, with names provided, will be confirmed as we clarify time and place.
