7. We The People, simply **measure** and **Null and Void** anything the Public Servants, paid on the Public purse do, that We The People do not like, do not agree with, impinges on freedoms and is a failure of **Rule of Law, All Are Equal Before The Law.**
8. This is the changing of the Ages.
9. This is an upgrade to Aquarian Architecture.
10. We facilitate by education and compassion understanding that this is a new paradigm for most, and a learning curve is involved.
11. This is the End of the Age of Pisces, as evidenced by many dates, not least, the pulling in of the Vatican financial instruments 30.9.2022
12. This is the beginning of the Age of Aquarius, an Age of humanitarianism, whereby humanity is **self governing**, not governed.
13. Guardianship, is evidenced by
 - 13.1. Unum Sanctum 1302,

14.2. The natural Creditor, deemed to be the debtor, is restored to the rightful position of Creditor.

14.3. If it has breath, it is Superior Jurisdiction.

14.4. If it does not have breath - Government and Artificial Intelligence (AI), it is inferior jurisdiction.

15. Remembering that a failure of **Rule of Law, All Are Equal Before The Law**, is an act of treason, fraud and slavery and will be addressed as such.

16. The continuing standard in Australia/Terra Australis for treason, is a life sentence to jail.

17. This can be upgraded at any time by We The People.

18. In others lands; it is death by hanging.

19. Such matters will be trialled in a Court of Rule of Law; which may also now be called a Common Law Court, a Court of Superior Jurisdiction.

20. And cannot be trialled in a Colonial Court, a court of Guardianship, and therefore of lower jurisdiction.

21. It is humbly and graciously recognised, with great respect, that First Nation People, have had the POSOC imposed upon them, and does include generational genocide and kidnap.

22. The private, foreign corporation that calls itself the Australian government, has no treaty nor blessing, from First Nation People to conduct business on these lands.

23. First Nation People recognise they are not beholden to the alleged authority of the private Corporation that calls itself the Australian Government, having never ceded their sovereignty to a foreign invading power, and therefore retain the right of 'First in Time, Best in Law'.

24. As a humanity, we are subjected to having our time consumed in matters such as the Emergency Management Amendment (Temporary COVID-19 Provisions) Bill 2022, a paper that is an 'absurdity in Law', is a time waster, for which many people are being paid, on the public purse, to debate. Thus generating a job for themselves, whilst many more important matters go unchecked, such as the homeless crisis.

25. This is theft of community resources for purposes that fail **Rule of Law, All Are Equal Before The Law**.

34. To **not** know this architecture at this advanced time in research, whilst occupying any position of decision making for the greater Collective, is deemed *incompetence* in both research and Law, and does result in a public listing of said individuals paid on the public purse.

39. Additionally: it must be noted, the WA Police have been contacted, via this Office of: We The People, for a meeting, in matters unrelated to this Bill, on the following dates:

39.1. As the first deadline of 12pm 30.9.2022 expired, without communication being made, a second date of 4.10.22, 12pm was offered, so that matters may be advanced.

39.2. As the second deadline of 12pm 4.10.2022 expired, without communication being made, a third date of 7.10.22, 12pm was offered, so that matters may be advanced.

39.3. As at 1.30pm 7.10.2022, the third offer has also failed to achieve any communication from the public service Office of the Police Commissioner.

39.4. And further, a 4th attempt was made to establish communication by a personal visit from 5 Common Law Sheriffs on 11.10.2022 to the WA Police Perth Headquarters. Sheriffs were eventually greeted by a Senior Constable, and colleague, who arrived with immediate attitude, refused to take the document to establish a new time and date, as at conclusion said; "you can leave the building now".

This is a measure of gross misconduct. This is a public servant, paid on the public purse, housed in a public building, telling We The People - the providers of the job, the pay, and the building, that we can leave.

This indicates an alarming confusion regarding jurisdictions and accountability. And in the face of

39.5. public servant sector to have any increased powers, such as sought via the Emergency Management Amendment (Temporary COVID-19 Provisions) Bill 2022, is alarming, dangerous and a failure of Rule of Law: All Are Equal Before The Law.

39.6. Since September 27, 2022, and the submission of the invitation to make contact; no contact has been forthcoming, which is to say, of all the public servants employed, there is no one occupying the role of Executive Secretary to the Commissioner of WA Police, who can respond to We The People in less than the current 21 days. This is deemed gross incompetence in Law.

40. Further, when the McGowan office was contacted to verify their jurisdiction, it deemed that it did not need to respond, and it did not respond. This is evidenced here:
